"Her Majesty the Queen may, on being satis-"fied that the Legislature of any British Posses-" sion has made adequate provision for the recog-" nition in that possession of Probates and Letters " of Administration granted by the Courts of the "United Kingdom, direct by Order in Council "that this Act shall, subject to any exceptions " and modifications specified in the Order, apply "to that Possession, and thereupon, while the "Order is in force, this Act shall apply accord-" ingly."

And whereas Her Majesty is satisfied that the Legislature of the British Possession hercinafter mentioned has made adequate provision for the recognition in that Possession of Probates and Letters of Administration granted by the Courts of the United Kingdom.

Now, therefore, Her Majesty, by virtue and in exercise of the powers by the above-recited Act in Her Majesty vested, is pleased by and with the advice of Her Most Honourable Privy Council to order, and it is hereby ordered, as follows:

"The Colonial Probates Act, 1892," shall apply to the British Possession hereunder mentioned :-

The Colony of Queensland.

"And whereas we deem it expedient to grant a gratuity to the mother of the late Edward Lynch, Stoker, who has died from the effects of injuries received while gallantly attempting to save the life of a comrade during the accident to Your Majesty's Torpedo Boat Destroyer 'Thrasher' Majesty may appoint, and also that Her on the twenty-ninth September, one thousand of Her Privy Council, order that the period of life of a comrade during the accident to Your Majesty's Torpedo Boat Destroyer 'Thrasher'

eight hundred and ninety-seven, notwithstanding the lapse of more than twelve months since the date of the injuries.

"We beg leave to recommend that Your Majesty will be graciously pleased by Your Order in Council to authorize us to grant a gratuity to Mrs. Lynch, as a special case, without regard to the before mentioned limit of twelve months."

Her Majesty having taken the said Memorial into consideration, was pleased, by and with the advice of Her Privy Council, to approve of what is therein proposed. And the Right Honourable the Lords Commissioners of the Admiralty are to give the necessary directions herein acc rdingly.
