THE Board of Trade have received, through the Secretary of State for Foreign Affairs, a copy of a Despatch from Her Majesty's Repre-

sentative at Trieste, enclosing the following Quarantine Notice, viz:—

Circular No. 6205 of the Imperial and Royal Marine Board to all the Imperial and Royal Offices and Officers and Subordinate Port and Sanitary Offices and Officers.

By order of the Imperial and Royal Ministry of Commerce, given by to-day's Telegram No. 29,300, with reference to the sanitary treatment of vessels arriving from Alexandria (Egypt), where at present bubonic plague exists, the Marine Board at Trieste decrees:—

Vessels arriving from the said port will be (according to Article VII, second paragraph, and of Article X of Government Circular of June 17th, 1897, No. 5684, and with reference to the circumstance that the voyage being of short duration they cannot be considered non-suspicious) treated as suspicious.

The passengers and their effects will be subjected to a very severe sanitary examination, to be only made by day at a sea lazaretto respectively in an isolated sanitary station.

Arrivals from the coast of Alexandria will have to undergo a prolonged observation, with repeated daily visits, at least till the end of the seventh day after departure, or till the end of the tenth day, should circumstances foreseen in Article X by the above-mentioned Government Circular take place, and also if there are transports of workmen, wandering persons, pilgrims, or groups of similar persons.

It is an understood thing that the other prescriptions of the Sanitary Convention of Venice, communicated by the said Government Circular, are still in force. The arrival of a vessel from Alexandria (Egypt) will have to be referred by telegraph to this (Trieste) Marine Board.

The prohibition of import and of transit, ordered by the Imperial and Royal Ministries of the Interior, of Commerce and of Finance by decree of May 27th, 1898 (B.L.I. No. 90), and notified by Government Circular of June 3rd, 1898, No. 5853, is extended also for arrivals from Alexandria.
