been made to secure space in some other part of the Metropolis. The site on which Your Royal Highness now stands will permit of the erection of a building not only adequate for the present needs of the Department, but capable of such extension as will suffice for all probable require-

ments for many years to come.

The interest which Her Majesty the Queen has been pleased to evince in the Savings Bank by authorizing Your Royal Highness to lay the first stone of this building on Her Majesty's behalf will render the occasion memorable in the history of the institution; and the honour which Your Royal Highness has conferred upon the Post Office by graciously consenting to attend to day is highly appreciated by myself and the whole staff of the Department.
