No. 371.—FRANCE—WEST COAST.

*Penmarc'h Approach—Rocks.*

THE French Government has given notice, dated 8th June, 1899, of the existence of the following rocks in the fairway north of Les Fourches, Approach to Penmarc'h:—

a. A rock awash at lowest tide, situated with the north-west rock (3 feet high) of Les Fourches bearing S. 1° W., distant 2½ cables, and south end of Nona Island in line with Menhir Turret N. 53° W.

Approximate position, lat. 47° 46' 5" N., long. 4° 16' 55" W.

b. A rock which dries 4 feet at lowest tide, situated with Pélénic Rock bearing N. 39° E., distant about 2½ cables, and south end of Men Daniel in line with Menhir Turret N. 53° W.

Approximate position, lat. 47° 45' 55" N., long. 4° 16' 15" W.

c. A rock which dries 6 feet at lowest tides, situated with north-west rock (3 feet high) of Les Fourches bearing S. 49° E., distant 1½ cables, and Kammouk Rock in line with Upper Guilfneec Lighthouse N. 31° E.

No. 372.—UNITED STATES—CONNECTICUT.

*Cornfield Point Light-Vessel—Temporary Alteration.*

THE United States Government has given notice, that on or about 21st June, 1899, Cornfield Point Light-vessel (flashing white light, &c.) would be temporarily withdrawn for repairs and replaced by relief light-vessel No. 20.

Relief light-vessel No. 20 will show two catoptric fixed lights, the light on the foremast being white, that on the mainmast red. This light-vessel, which is schooner-rigged, with two masts, without bowsprit or funnel, is dark grey in colour, with "Relief" on each side, and "No. 20" on each quarter in black.

Also, that during thick or foggy weather a bell will be sounded by hand on board this light-vessel.

Approximate position, lat. 41° 13' N., long. 72° 22' W.
