a. Klofvens Light (4th order) will be white fixed, visible over an arc of about 40°, situated on the south-east point of the Island.

occulting, with two eclipses in succession every ten seconds, visible over an arc of about 40°, situated on the south-west part of the Island.

c. South light (6th order) will be white fixed, situated on the south-west part of an Island.
