ELEMENTARY EDUCATION ACTS, 1870-1893.

THE Lords of the Committee of the Privy Council on Education have issued an order this day for the formation of a School Board in the undermentioned Parish:-

Department), London, September 22, 1899. THE Board of Trade have received, through the Secretary of State for Foreign Affairs, a copy of a Despatch from Her Majesty's Representative at Christiania, enclosing the following Notice respecting quarantine, viz. :-

Royal Quarantine Proclamation for Norway.

I. Vessels, on which during the voyage there have been or upon whose arrival there still are persons attacked by plague, are directed to the quarantine establishment on Oddero, near Christianssand, where they are subjected to the following treatment :-

on Odderö and are kept in seclusion for 10 days after they are cured.

The dead are buried with all the precautions

laid down by the quarantine regulations.

(b.) Clothes and other objects which have been used by person on board, as well as the cabins in which the sick have lain, shall be cleansed to the full degree laid down by the Quarantine Commissioners. The Quarantine Commissioners are also empowered, if they think proper, to order a cleansing of other objects and other parts of the ship than those already named.

(c.) As soon as possible after the arrival of the ship, its closets shall be cleansed, its bilge water disinfected and pumped out, and the drinking water

on board exchanged for fresh water.

(d.) The vessel as well as all the persons on board will be kept isolated for 10 days after all such persons as have died of plague, or have been attacked by or suspected of it, have passed out, and after the cleansing described above has been carried out.

As long as the isolation lasts, the vessel must carry the quarantine flag, and have no other communication with shore or with other vessels than the Quarantine Commissioners permit.

If any fresh case of plague breaks out among the persons remaining on board, a fresh period of 10 days must begin from the date when this fresh

case is completely dealt with.

II. Vessels which, without having been in any of the conditions described in I, come from a place attacked by plague or have had any sort of communication with vessels carrying plague patients on board or persons coming from a plague centre, must on reaching this country be kept isolated at a place indicated by the Quarantine Commissioners until 10 days have elapsed since the time when the vessel last left a place infected with plague or had communication with a plaguesmitten vessel.

As soon as possible after the arrival of the ship its closets shall be cleansed, its bilge water disinfected and pumped out, and the drinking water on

board renewed. If the vessel is released after this said period las elapsed, the clothes and other objects which have been used by people on board shall be cleansed in full accordance with the directions of
