same manner as if they were included in the schedule to the Act:-

Wryneck, Swallow, Martin (both species), Swift, Bearded Tit, Red-backed Shrike, Kestrel, Osprey, Hobby, Buzzard, Honey Buzzard, Peregrine Falcon, Raven, Kentish Plover, Bustard, Black-headed Bunting, Corn Bunting, Yellow Hammer, Cirl Bunting, Reed Bunting, Snow Bunting, Flycatcher (both species), Landrail, Linnet, Merlin, Nuthatch, Redstart, Stonechat, Long-tailed Tit, Great Tit, Blue Tit, Coal Tit, Marsh Tit, Crested Tit, Wagtails (all species), Whitethroat, Lesser Whitethroat, Garden Warbler, Blackcap, Dartford Warbler, Reed Warbler, Sedge Warbler, Grasshopper Warbler, Chiffchaff, Willow Warbler, Wood Warbler, Wheatear, Whinchat, Fire-crested Wren, Golden-crested Wren, Tree Sparrow.

Certain Birds protected during the whole of the Year.

IV. During the period from the 1st day of September in any year, to the last day of January following, both days inclusive, the taking or killing of the following Wild Birds is prohibited throughout the Administrative County of West Sussex:

Oriole, Chough, Kingfisher, Hoopoe, Dartford Warbler, Bearded Tit, Buzzard, Honey Buzzard, Osprey, Common Kite, Nightjar or Goatsucker, Green Woodpecker, Great Spotted Woodpecker, Lesser Spotted Woodpecker, White Owl, Common Bittern, Spoonbill, Stone Curlew (Great Plover, Thick Knee), Avocet, Great Crested Grebe, Goldfinch, Crossbill, Woodlark, Pied Flycatcher, Little Bittern, Siskin, Linnet, Redpole, Wheatear, Raven, Swallow, Martin (both species), Tree Sparrow.

All Birds protected on Sundays in certain areas. V. During that period of the year to which the protection given by the Wild Birds Protection Act of 1880, as extended by clause II of this Order does not apply, the taking or killing of Wild Birds on Sundays is prohibited in that part of the Administrative County of West Sussex which is comprised in the Poor Law Unions of Westbourne, Westhampnett, East Preston, Thakeham, Midhurst, and Petworth, and in so much of the Steyning Union as is in the said Administrative County, which area is outlined in red on a map deposited with the Clerk of the County Council, sealed with the seal of the Secretary of State, and

dated the 21st September, 1899.

All Eggs protected in certain areas.

VI. The taking or destroying of the Eggs of any species of Wild Bird is prohibited for a period of five years from the date of this Order within the undermentioned areas :-

1. All land in West Sussex situate within 200 yards of the high water mark at ordinary high tide of Chichester Harbour.

2. Old Pagham Harbour (as reclaimed in 1876) and all land situate within 200 yards of its boundaries, including Allstone Beach; also all land situate within 200 yards of the Level Commissioners Rife, running from Ferry Sluice past Medmeney Sluice as far as Marsh Farm, Earnley, which two areas are outlined in blue on a map deposited with the Clerk of the County Council, sealed with the seal of the Secretary of State, and dated the 21st September, 1899.

Certain Eggs protected throughout the County. VII. The taking or destroying of the Eggs of the following Wild Birds is prohibited throughout the Administrative County of West Sussex ;-

Bearded Tit, Buzzard, Dartford Warbler, Goldfinch, Oriole, Hobby, Honey Buzzard, Hoopoe, Kentish Plover, Kestrel, Common Kite, Terns (all species), Heron, Raven, Nightjar, Kingfisher, Nightingale, Owls (all species), Wryneck, Common Bittern, Redshank and other Sandpipers, Dotterels, Spoonbill, Stone Curlew (Great Plover, Thick Knee), Avocet, Great Crested Grebe, Green Woodpecker, Great Spotted Woodpecker, Lesser Spotted Woodpecker, Crossbill, Woodlark, Goldencrested Wren, Wheatear, Red-backed Shrike.

VIII. The Order of the 18th January, 1899, is

hereby repealed.

GENERAL ORDER of the Local Government Board: Rescission of Order removing suspension of Articles of General Order; District Medical Officer's Fees:-

Honiton Union .- Parish of Yarcombe. To the Guardians of the Poor of the Honiton Union ;-

And to all others whom it may concern.

WHEREAS by an Order dated the 21st day of April, 1853, the Poor Law Board suspended, so far as regards the District Medical Officers of the Honiton Union, and until that Board should by Order otherwise direct, the operation of Articles 177, 181, and 183 of the General Order of the Poor Law Commissioners dated the 24th day of July, 1847, which provided for the payment of special fees to District Medical Officers in certain cases;

And whereas by a further Order dated the 14th day of December, 1895, We, the Local Government Board, removed the suspension of the said Articles, so far as regards the Medical Officer for the time being of the parish of Yarcombe, in the said Union

And whereas the Medical Officer for the said Parish has resigned; and it is expedient that the last above-recited Order should be rescinded:

Now therefore, in pursuance of the powers given to Us by the Statutes in that behalf, We hereby rescind the said Order dated the fourteenth day of December, one thousand eight hundred and ninety-five.

(Swine-Fever Infected Area.)

THE Board of Agriculture, by virtue and in exercise of the powers in them vested under the Diseases of Animals Acts, 1894 and 1896, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows;
