(1.) To mortgage and pledge the Undertaking and the whole or any part of the property and rights, both present and future, of the Company, and to borrow and raise or secure the payment of moncy by the issue of debentures, debenture stock, or other obligations or securities, either with or without any specific or floating charge or security on the Undertaking and all or any part of the property and rights of the Company, including its uncalled capital (if any) for the time being, and either perpetual or otherwise, and to redeem or pay off any such securities, and to issue the securities or obligations of the Company for such consideration or purposes, as the Company may think fit. (m.) To enter into partnership or into any arrangement for sharing profits, union of interests, co-operation, joint adventure, reciprocal concession, or otherwise with any person, corporation or company carrying on or engaged in or about to carry on or engage in any business or transaction which this Company is authorized to carry on or engage in, or any business or transaction capable of being conducted so as directly or indirectly to benefit this Company. (n.) To purchase, take on lease, or in exchange, hire, or otherwise acquire any real and personal property, and any rights or privileges which the Company may think necessary or convenient for the purpose of its business. (o.) To construct, maintain, and alter any buildings or works neces-sary or convenient for the purposes of the Company. (p.) To divide the shares in the original capital, and any new shares into different clases, and to issue them with any special rights, pre-ferences, conditions, or qualifications as regards dividends, capital, voting or otherwise attached thereto. (q.) To establish, aid, and subsidize any institutions, associations, or funds established for, or calculated to promote, the welfare of employers

or employed in connection with any of the trades or businesses which this Company is authorized to carry ov. (r.) To adopt such means of making known the products of the Company as may seem expedient, and in particular by advertising in the Press, by circulars, by purchase and exhibition of works of art, or interest, by publication of books and periodicals, and by granting privileges, rewards, and donations. (s.) To receive money on deposit at interest or otherwise, and to make, d:aw, accept, indorse, issue, discount, and otherwise deal with promissory notes, bills of exchange, letters of credit, circular notes, and other mercantile instruments. (t.) To sell the Undertaking of the Company or any part thereof for such consideration as the Company may think fit, and in particular for shares, debentures, or securities of any other Company having objects altogether or in part similar to these of this Company.
