Cape Rosier—Fog Signal Altered.

THE Government of the Dominion of Canada has given notice, that on and after 1st November, 1899, the fog horn at Cape Rosier, Gaspé Bay Approach, will be replaced by a whistle, which during thick or foggy weather will give one blast of ten seconds duration every minute.

If the whistle is disabled a horn will be used in a similar manner.

River Tyne Entrance—Wreck.

THE Tyne Improvement Commissioners have given notice, dated 11th October, 1899, that the wreck of a steamship lies sunk in the northern part of the entrance to the River Tyne. It is situated with the north pier head bearing S. 56° W., distant 2½ cables, and Sharpness Point N. 49° W., the least depth over it being 18 feet at low water.

A green buoy marked "wreck" has been moored immediately to the eastward of the wreck, and at night when practicable a steam tug exhibiting two white fixed lights horizontally placed will mark the position.
