

In Parliament—Session 1900.

Sheffield Corporation.

(Extension of Boundaries of the City and County Borough of Sheffield; Extension of Powers and Jurisdiction of Corporation and of the Recorder, Clerk of the Peace, Justices, Police, and other officers to Added Area; Exemption of Added Area from Contribution to County Expenditure and County Police Rates, and Separation thereof from West Riding of the County of York and County of Derby respectively; Consequential Alterations of School Boards, School Attendance Committees, Highway and Burial Boards, Boards of Guardians, Parochial Committees, Overseers, Constitution of Corporation as Burial Board in Added Area; Alteration of Electoral Districts; Provisions as to Municipal and other Elections; Constitution of Wards and Alteration of Names, Numbers, and Boundaries of Wards, and Allocation thereto of existing Councillors; Consolidation of Townships; Street Widening and Works; Compulsory Purchase of Lands; Power to Purchase parts only of certain Properties; Construction of Tramways; Motive Power of Tramways; Tolls and Charges; General Powers to Corporation with respect to Finance; Alteration and Confirmation of Title of Corporation; Provisions as to Streets, Buildings, and Police and Sanitary Matters Bye-laws with respect thereto; Amendment of Acts, &c.)

NOTICE is hereby given, that the Mayor, Aldermen and Citizens of the City of Sheffield as the Municipal, Sanitary and Local Authority of and for the City and County Borough of Sheffield (hereinafter referred to as "the existing City"), in all which characters they are hereinafter included under the expression "the Corporation," intend to apply to Parliament in the next Session for an Act for all or some of the following purposes (that is to say):—

Extension of City.

1. To alter and extend the boundary of the existing City, and to include within the boundary as extended, in addition to the existing City, the parishes, parts of parishes, extra-parochial and other places hereinafter defined, or some of them, or some part or parts thereof respectively, all in the West Riding of the County of York and the County of Derby.

The numbers hereinafter specified in relation to any properties in a parish are in all cases, unless otherwise expressly stated, the numbers whereby those respective properties are distinguished on the  $\frac{1}{2500}$  Ordnance map of that parish.

The proposed additions to the existing City (hereinafter referred to as "the added area") are the following (that is to say):—

In the West Riding of the county of York.

(a) So much of the parish of Ecclesfield as is bounded by a line commencing at a point in the boundary of the existing City in the centre of the Blackburn Brook, at the extreme north-eastern point of the City near the Meadow Hall Works, and about 1½ yards west of Meadow Hall-road, passing thence in a north-westerly direction along the centre of the old course of the said Blackburn Brook, crossing the Midland Railway at a point about 90 yards south of Meadow Hall Road, thence in a westerly and north-westerly direction along the centre of the said Blackburn Brook to a point near the Woolley Wood, thence southward along a brook or stream to a point at the northern extremity of a new street adjoining the eastern junction of Station-road and Fowler-street, thence in a westerly

direction along the stream forming the southern boundary of Woolley Wood, thence along the southern boundary of field, No. 89, on the Ordnance Map, thence through the centre of a small plantation, No. 95, at the south east corner of Oaks-lane, thence in a north-westerly direction along the east side of Oaks-lane for a distance of 330 yards or thereabouts, thence in a line from the centre of Oaks-lane in a westerly direction to the south-east corner of field, No. 1005, following the southern boundary of the same field, thence along the eastern and northern boundaries of field, No. 1004, thence along the eastern side of Common-road in a southerly direction, crossing Common-road, thence westward along the southern boundary of fields, Nos. 1009 and 1009A, to Sicey-lane, thence crossing Sicey-lane, thence along the southern boundary of field, No. 1013, and the south-eastern boundaries of fields, Nos. 982, 980, 979, 978 and 977, to Sheffield-lane, thence in a northerly direction along the east side of Sheffield-lane, crossing Sheffield-lane, and following in a westerly direction the southern boundaries of fields, Nos. 940, 941, 942, 947, 948, 950, and 951, thence in a southerly direction along the eastern boundary of field, No. 887, to Elm-lane, thence crossing Elm-lane, thence in a southerly direction along the eastern boundary of field, No. 886, thence along the eastern and southern boundary of field, No. 872, thence along the north-eastern fence of Carr-lane to the City boundary near Longley House, thence along the City boundary to the centre of the Blackburn Brook aforesaid, and point of commencement of the said line.

(b) Also so much of the said parish of Ecclesfield as is bounded by a line commencing in the centre of the River Don, on the north-western boundary of the existing City, 170 yards east of Penistone-road, nearly opposite the entrance to Hillsbro' Park, passing thence in a north-westerly direction along the centre of the River Don to a point opposite a fence forming the north-western boundary of field, No. 527 on the Ordnance map, thence in a south-westerly direction along such fence to the main road from Huddersfield to Sheffield, thence crossing such road, thence in a south-westerly direction along the south-eastern boundary of the grounds of the South Yorkshire Lunatic Asylum to Church-lane, thence in a line crossing such lane to the north-west corner of field, No. 449, thence along the fence forming the eastern boundaries of fields, Nos. 447, 446, and 431, to Coalpit-lane, thence along the north-eastern boundary of Coalpit-lane, thence along the north-western and western boundary of the Occupation-road, No. 403, thence along the southern boundary of fields, No. 402 and 394, thence along the western boundary of the park attached to Loxley House, No. 359, thence along the southern boundary of Rodney-hill, thence in a southerly direction along the fence forming the eastern boundary of field, No. 342, thence along the southern boundary of the said field, No. 342, thence crossing a certain occupation road, No. 298, thence in a southerly direction along the east side of a footpath to Loxley-road,
