poration in cases of tuberculosis, or other disease, as aforesaid, and in other respects to make better provision for the prevention of infectious disease, whether within or beyond the city.

52. To authorise the Corporation and the Corporation of Barnsley to enter into agreements as to the laying down of the line of pipes, No. 1, authorised by the Barnsley Corporation (Water) Act, 1896, along a portion of the road leading from Deepcar to Langsett, at or near Underbank, as proposed to be diverted under the powers of the Sheffield Corporation Water Act, 1896, and as to the cost and expenses of such diversion, and the laying down of such line of pipes.

among other purposes, that is to say:—

1. To authorise the Company to make and maintain, wholly in the county of Lancaster, the following works or some of them, or some part

or parts thereof (that is to say):-

(1) A service tank, wholly situate in the parish of Aughton, in the rural district of West Lancashire, in the said county in the field or enclosure numbered 915 on the \(\frac{1}{2500}\) ordnance map of that parish published in 1893, and adjoining and on the south-westerly side of the existing Gorse Hill service reservoirs of the Company.

(2) A line or lines of pipes (No. 1), wholly in the said parish of Aughton, commencing in the said intended service tank, and terminating by a junction with an existing pipe of the Company at a point near to the southeasternmost corner of the said reservoirs.

(3) A high level pumping station, with water tower and tank, wholly situate in the said parish of Aughton on land belonging to the Company and adjoining the south-easternmost side of the said reservoirs.

(4) A line or lines of pipes (No. 2), wholly in the said parish of Aughton, commencing in the said high level pumping station by a junction with the said intended line or lines of pipes (No. 1) and terminating at Aughton Moss by a junction with an existing pipe of the Company in the road leading from Ormskirk to Liverpool at or near the junction therewith of Long-lane.

(5) A communication road, wholly in the said parish of Aughton, commencing at or near the said intended high level pumping station and at the north-westerly corner of the field or enclosure, number 916 on the said ordnance map, and terminating by a junction with the said road leading from Ormskirk to Liverpool at a point 2 chains, or thereabouts, measured in a north-easterly direction from the junction therewith of the said Longlane.

2. To enable the Company from time to time to make and maintain all aqueducts, pipes, culverts, tunnels, drains, sluices, cocks, valves, pumping stations, tanks, basins, wells, water-towers, banks, walls, roads, ways, approaches, engines, pumps, machinery, apparatus, and appliances, as may be necessary or convenient in connection with the before-mentioned works or any of them, or for obtaining, storing, distributing, and using of their water or for the general purposes of their undertaking.

3. To enable the Company to deviate from the lines and levels of the works to any extent defined by the Bill or prescribed by Parliament.

4. To authorise the Company to break up, and to cross over roads and footpaths, and to stop up or divert all roads and footpaths marked on the deposited plans as intended to be stopped up or diverted, or as are included within the limits of the lands which may be compulsorily taken, and which are so taken, and to appropriate the site and soil of public and private streets, roads, lanes.
