No. 742.—ENGLAND—SOUTH COAST.

*Looe Jetty Head—Light.*

INFORMATION has been received from the Inspecting Commander of the Coastguard, Plymouth that on and after 27th November, 1899, a fixed dioptric light of the 6th order will be exhibited from the jetty head, Looe Harbour, showing red from the bearing of S. 44° W., through west, to N. 76° W., white from N. 76° W. to N. 30° W., red from N. 30° W. to N. 7° W., obscured from N. 7° W., through north, to N. 30° E., and white from N. 30° E., through east and south, to S. 44° W.

Approximate position on Chart No. 1914, lat. 50° 21' 10" N., long. 4° 27' 5" W.

On the same date the green fixed light shown at the lifeboat station will be discontinued.
