Department); London, December 5, 1899. THE Board of Trade have received, through the Secretary of State for Foreign Affairs, the following translation of a Notice respecting quarantine issued by the Danish Government, viz. : —

Quarantine Notice.

In consequence of the fact that it has been officially reported that a considerable number of cases of small-pox have broken out at Hull, it is ordered that the regulations in Second Section I of the Law regarding the Prevention of the Introduction of Contagious Diseases into this country (Denmark), of the 2nd of July, 1880, shall until further notice come into force as regards vessels which arrive from or have been in connection with Hull, or which on the voyage have held communication with ships coming from that port.

(a.) Quarantine is now in force with regards to the town of Alexandria and the ports of Portugal.

(b.) The regulations in the Second Section I of the Law for Preventing the Introduction of Contagious Diseases of the 2nd of July, 1880, are in force for the following places :-

The other ports of Egypt.

Ports on the Red Sea.

Ports in Tonquin and Cochin China, as well as the East Indies, including the Dutch East Indian Colonies and Hull,

(c.) Prohibition of importation and rules for disinfection.

From the places mentioned in paragraph (b)-Hull being excepted-it is forbidden to import rags and also clothing-wool, so far as a convincing proof is not produced of their having been carbonized or washed, and heated to 8° Celsius.

From the places mentioned-again with the State of Parage exception of Hull-it is further forbidden to im- bubonic-plague.

port dirty linen, dirty clothing of any kind, and dirty bed-clothes, unless they accompany passengers as part of their baggage, or unless it is attested by the receiver on his honour that the said objects only enter the country in connection with the change of residence of their possessor. In cases where such objects may be imported this must not be permitted if there is any reason to suppose them to be specially foul, or in any other way open to suspicion, until they have been subjected to disinfection in a public manner.

From the places named in Section A it is prohibited to import rags, used wadding, clothingwool, paper rubbish, hair, skins, dirty bags, carpets, embroideries, raw meat refuse, claws, hoofs, wool or raw silk, as well as dirty linen, dirty articles of clothing and bed-clothes, unless these dirty articles are the personal goods of passengers. Linen, articles of clothing an l bedclothes, which are brought by passengers along with them, must be washed in public.

This notice comes into force at once.

Vessels from Lisbon and Madeira can be received here at once if Federal Government permits it. Unable to obtain more definite information."
