TENDERS FOR LOANS ON TREASURY BILLS.

1. THE Lords Commissioners of Her Majesty's Treasury hereby give notice that Tenders will be received at the Chief Cashier's Office, at the Bank of England, on Monday, the 26th instant, at one o'clock, for Treasury Bills to be issued under the Acts 40 Vic., cap. 2, 52 Vic., cap. 6, and 63 Vic., cap. 2, to the amount of £2,000,000, for the replacement of £1,500,000 falling due on the 2nd proximo, and the issue of £500,000 under the Treasury Bills Act, 1899.

2. The Bills will be in amounts of £1,000, £5,000, or £10,000. They will be dated the 2nd March, 1900, and will be payable at three months, or six months, or twelve months, after date (at the option of the persons tendering), viz. :—on the 2nd June, 1900, or 2nd September, 1900, or 2nd March, 1901, respectively.

3. *The Tenders must specify the net amount per cent. which will be given for the amounts applied for; and the Tenders of private individuals must be made through a London Banker.*

4. The Bills will be issued and paid at the Bank of England.

5. The persons whose Tenders are accepted will be informed of the same on Tuesday, the 27th instant, and payment in full of the amounts of the accepted Tenders must be made to the Bank of England not later than three o'clock, on Friday, the 2nd proximo.

ORDER of the Local Government Board: District Auditor: Assignment of District and Duties (County Councils) :—

North-Eastern Counties Audit District.

To George Haslehurst, District Auditor ;—

To the County Councils of the several Administrative Counties named in the Schedule to this Order, and to the County Council of the Administrative County of Norfolk ;—

To the Visiting Committees of any Lunatic Asylums belonging wholly or in part to one or more of the said County Councils and not belonging in part to any other County Council ;—

To the Local Fisheries Committee for the Eastern Sea Fisheries District ;—

And to all others whom it may concern.

WHEREAS by Section 4 of the District Auditors Act, 1879, it is enacted that the Local Government Board may from time to time assign to District Auditors their Duties, and the Districts in which such Auditors respectively are to act, and may from time to time change wholly or in part such Duties or Districts ;

And whereas by an Order dated the 16th day of June, 1897, We, the Local Government Board, certified the appointment of the said George Haslehurst as a District Auditor, and directed that, unless We otherwise prescribed, it should be the duty of the said District Auditor to audit the Accounts of the County Councils of the several Administrative Counties named in Schedule A to that Order (such Counties being those named in the Schedule to this Order) and the other Accounts referred to in Article I of such Order, so far as the same might relate to any period prior to the 1st day of April, 1897 ; and We further directed that the District in which the said George Haslehurst should act as Auditor, and which should be termed the "North-Eastern Counties Audit District," should, for the performance of the duties assigned to him by Article I of the said Order, comprise the area for the time being included in the said several Administrative Counties and the area comprised in the Eastern Sea Fisheries District ;

And whereas by Orders dated respectively the 16th day of March, 1898, and the 24th day of January, 1899, We altered the said Order dated the 16th day of June, 1897, as therein mentioned, the effect of such alterations being the substitution in Article I of that Order of the words "first day of April, one thousand eight hundred and ninety-nine," for the words "first day of April, one thousand eight hundred and ninety-seven" ;

And whereas it is expedient that the said Order should be further altered as hereinafter mentioned :

Now therefore, in pursuance of the powers given to Us in that behalf, We hereby alter the said Order dated the sixteenth day of June, one thousand eight hundred and ninety-seven (as altered as aforesaid), by the substitution in Article I thereof of the words "first day of April, one thousand nine hundred," for the words "first day of April, one thousand eight hundred and ninety-nine" ; and We do hereby Order that the said Order as so altered shall have full force and effect as if the words hereby substituted therein had been originally contained in such Order.
