HIS Royal Highness The Prince of Wales has been pleased to direct Letters Patent to be passed under the Seal of the Duchy of Cornwall, appointing Robert Harvey, of Trenouth, Grampound Road, in the county of Cornwall, Esq., Sheriff of the County of Cornwall.
