## SHORES OR BANKS OF THE SEA AT GOODWICK, FISHGUARD BAY.

REMOVAL OF MATERIALS PROHIBITED. WHEREAS the Board of Trade, acting in pursuance of the Harbours Act. 1814, as amended by the Harbours Transfer Act, 1862, find it necessary for the protection of the Port of Cardigan to prohibit the taking or removing of any shingle or ballast from the shores or banks of the sea at Goodwick, between a point 85 yards south of Goodwick Bridge and a point 80 yards south of the property known as "Brynhyfryd," being within the said port.

Now the Board of Trade do hereby, by this Order, prohibit the taking or removing of any shingle or ballast from the shores or banks of the sea between the points above mentioned.

### ORDER OF THE BOARD OF . AGRICULTURE.

(DATED 3RD APRIL 1900.)

DEPTFORD FOREIGN ANIMALS WHARF ORDER OF 1900.

THE Board of Agriculture, by virtue and in exercise of the powers in them vested under the Diseuses of Animals Acts, 1894 and 1896, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows :

# Restriction of South American Cattle to Parts

of the Wharf. 1.-(1.) Animals brought from the country of the Argentine Republic or from Uruguay shall not be landed at the Deptford Foreign Animals Wharf, except in accordance with the provisions

of this Article. (2.) The animals may be landed with the permission of an Inspector of the Board, which permission will only be given where the Inspector is satisfied that sufficient lairage and other accommodation is available for the landing and slaughter of the animals in accordance with the provisions of this Article.

(3.) The animals shall be landed at the Upper Jetty and not at any other part of the Wharf, and when landed shall be driven by lairage-men to such lairs within the limits of the Wharf as may be specially approved for that purpose by an Inspector of the Board.

(4.) After such examination as may be required by an Inspector of the Board, the animals shall either be immediately slaughtered in the lairs in which they then are, or they may, with the permission of an Inspector of the Board, be forthwith moved to a slaughter-house specially approved for that purpose by an Inspector of the Board and there immediately slaughtered.

(5.) The slaughter of a cargo when commenced shall be continued without intermission and completed as soon as practicable.

Exclusion of other Animals from such parts of the Wharf.

2. No animal, other than an animal brought from the country of the Argentine Republic or from Uruguay, shall be landed at the Upper Jetty or when landed be moved into any lair or slaughter-house approved by the Inspector for the purposes of the preceding Article of this Order.
