THE Queen has been graciously pleased to signify Her intention to confer the decoration of the Victoria Cross on the undermentioned Officer, whose claims have been submitted for Her Majesty's approval, for his conspicuous bravery at the battle of Colenso, as stated against his name :—

Regiment.	Name.	Act of Courage for which recommended.
Royal Army Medical Corps	Major William Babbie, C.M.G.	At Colenso, on the 15th December, 1899, the wounded of the 14th and 66th Batteries, Royal Field Artillery, were lying in an advanced donga close in the rear of the guns without any Medical Officer to attend to them, and when a message was sent back asking for assistance, Major W. Babbie, R.A.M.C., rode up under a heavy rifle fire, his pony being hit three times. When he arrived at the donga, where the wounded were lying in sheltered corners, he attended to them all, going from place to place exposed to the heavy rifle fire which greeted anyone who showed himself. Later on in the day, Major Babbie went out with Captain Congreve to bring in Lieutenant Roberts, who was lying wounded on the veldt. This also was under a heavy fire.

THE Board of Trade have received, through the Secretary of State for Foreign Affairs, a copy of a Despatch from Her Majesty's Representative at Honolulu, enclosing the following Proclamation respecting quarantine, viz.:—

Proclamation.

By the President of the Republic of Hawaii.

Whereas, it hath been shown to my satisfaction that, by reason of the existence of an infectious or contagious disease known and designated as plague, in certain foreign countries, there is serious and continuing danger of the introduction of the same into the Hawaiian Islands, and that, notwithstanding the quarantine defence, this danger is so increased by the introduction of certain food-stuffs from such countries, that a suspension of the right to introduce the same is demanded in the interest of the public health.

Now, therefore, by virtue of the power in me vested by law, I do hereby prohibit the introduction into the Hawaiian Islands from all foreign ports and places infected with bubonic plague, and more particularly from the port of Hongkong, China, all or any of the following described food-stuffs, to wit:—

Cuttle fish and other dried fish, lily flower, oranges, dates, lichees, nuts, fungus, ducks, pork, sausage, dried meats, dried vegetables, cabbage, olives, birds' nests, eggs, hizo (cooked rice and beans), sea weed, mushrooms.

Said prohibition to continue as to each of said ports or places until after the expiration of sixty (60) days from the time said disease known and designated as plague shall cease to exist in said port or place.

This Proclamation to take effect from and after the date hereof.

WILD BIRD (ENGLAND).

The Wild Birds Protection (County of Norfolk) Administrative Order, 1900.

Dated 9th April, 1900.

IN pursuance of the powers conferred on me by the Wild Birds Protection Acts, 1880 to 1896, and upon application by the County Council of the Administrative County of Norfolk, I hereby make the following Order :—

Title.

I. This Order may be cited as "The Wild Birds Protection (County of Norfolk) Order, 1900."

BIRDS.

Additions to Schedule of Act of 1880.

II. "The Wild Birds Protection Act, 1880," shall apply within the County of Norfolk to the following species of Wild Birds in the same manner as if those species were included in the schedule to the Act :—Bearded Titmouse or Reed Pheasant, Crossbill, Sandmartin.

Extension of Close Time throughout the County.

III. The period during which the killing or taking of Wild Birds is prohibited by the Act of 1880 shall be extended throughout the County of Norfolk, so far as regards all Birds mentioned in the schedule to that Act, except the Snipe, Teal, and all species of Wild Duck, so as to be from the 1st March to the 31st August in any year.

All Birds Protected on Sundays in certain Areas.

IV. During the period from the 1st day of September in any year to the last day of February following, the taking or killing of Wild Birds on Sundays is prohibited within the areas described in Article V, paragraphs (a), (b), (c), and (d) of this Order.

EGGS.

All Eggs Protected in certain Areas.

V. The taking or destroying of the eggs of any species of Wild Birds is prohibited during the period expiring on the 30th day of April, 1901, within the following areas :—

(a.) Hickling Broad, Whitesley and Heigham Sounds, Blackfleet Broad, Horsey Mere, Martham and Somerton Broads, and the rands, skirts, and walls thereof, and fens and reed grounds apper-

taining thereto respectively, and the islands therein, and the dykes communicating therewith, including the Hundred Stream or Thurne River and ancient bed, and the rands and walls thereof from Heigham Bridge to the sea at Winterton, and all the marshes and low-lying and uncultivated lands, fens, reed grounds, warrens, marram or sand hills and sea shore, to the line of high water mark, in the several parishes of Waxham, Horsey, Potter Heigham, and Hickling, and such part of the parish of Catfield as lies to the east of the Midland and Great Northern Joint Railway.

(b.) The warrens, marram or sand hills and sea shore, to the line of high water mark, in the parish of Winterton.

(c.) The series of Broad known as Ormesby, Rollesby, Hemsby, Filby, and Burgh Broad, and the rands, skirts, and walls thereof, and the dykes communicating therewith, and the fens, reed grounds, and low-lying lands, marshes, and pastures adjacent thereto, including Lady Broad or Hard Fen Water, in the parish of Filby, Brandyke Broad, in the parish of Buigh St Margaret, and Muckfleet Dyke, and the marshes and low-lying lands and pastures near or adjacent thereto respectively.

(d.) The whole of the foreshore of the County of Norfolk, including the shingle, sand hills, salt marshes, creeks, and other unenclosed lands extending from high water mark to the first boundary of enclosed or cultivated land separating the foreshore from them.

Certain Eggs Protected throughout the County.

VI. The taking or destroying of the eggs of the following species of Wild Birds is prohibited throughout the County of Norfolk, viz.:—
1. Bearded Titmouse or Reed Pheasant (*Panurus biarmicus*). 2. Crossbill (*Loxia curvirostris*). 3. Owls—all species. 4. Wild Ducks and Teal—all species. 5. Norfolk Plover, Stone Curlew or Thickknee (*Cedionemus scolopax*). 6. Rough or Reeve (*Machetes pugnax*). 7. Ring Dotterel, Ring Plover, or Stone Runner (*Ægialitis hiaticula*). 8. Oyster Catcher or Sea Pie (*Hamatopus ostralegus*). 9. Terns, Sea Swallows, Pearls or Dip Ears, (*Sterna*)—all species. 10. Great Crested Grebe or Loon (*Podiceps cristatus*). 11. Kingfisher (*Alcedo ispida*). 12. Sandmartin (*Cotyle riparia*).

**DEPTFORD FOREIGN ANIMALS WHARF ORDER
OF 1900 (No. 2).**

THE Board of Agriculture, by virtue and in exercise of the powers in them vested under the Diseases of Animals Acts, 1894 and 1896, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows:

Time for Slaughter.

1.—(1.) An animal brought from the country of the Argentine Republic or from Uruguay shall be slaughtered within thirty-six hours after the landing thereof at the Deptford Foreign Animals Wharf.

(2.) An animal brought from any other country shall be slaughtered within five days after the landing thereof at such Wharf exclusive of the day of landing.

Restriction on Access to Deptford Foreign Animals Wharf.

2.—(1.) Any person desiring to enter the Deptford Foreign Animals Wharf may be required by any officer of the Corporation of London, authorized in that behalf by the Corporation, to state the nature of the business necessitating such entry, and if he declines to make such statement, or if the officer of the Corporation is not satisfied as to correctness of such statement, or that the business necessitates the entry of such person, the officer may prohibit the entry of such person into the Wharf.

(2.) If any person, whose entry into the Wharf is so prohibited, enters or attempts to enter into the Wharf he shall be deemed guilty of an offence against the Diseases of Animals Act, 1894.

Short Title.

3. This Order may be cited as the DEPTFORD FOREIGN ANIMALS WHARF ORDER OF 1900 (No. 2).

(i.) The following classes of persons are ineligible to compete, viz. :—

Persons actually serving in the Army and Navy.

(ii.) The following classes of persons will not be eligible unless they obtain the permission of the authorities of their department to attend the examination, before the commencement of the competition, viz. :—(a) Persons holding situations in the Civil Service, (b) Apprentices in Her Majesty's Dockyards, and Engineer Students in the Navy.

(iii.) Persons who have been trained in Training Colleges at the public expense will not be qualified to receive appointments until the consent of the Board of Education in England, the Committee of Council on Education for Scotland, or the Commissioners of National Education, Ireland, as the case may be, given in conformity with rules sanctioned by the Lords of the Treasury, has been notified to the Civil Service Commissioners.

(iv.) In reckoning age for competition the following allowances will be made, viz. :—(1) Persons who have served in the Army or Navy may deduct from their actual age any time during which they have served ; (2) Members of the Militia, the Imperial Yeomanry, the Honourable Artillery Company, or the Volunteers (whether commissioned or non-commissioned), may deduct from their actual age any time spent on actual military service, such time being reckoned by the number of days for which they received Army pay ; (3) Persons who have served for two full consecutive years (a) in any Civil situation to which to which they were admitted with the certificate of the Civil Service Commissioners ; or (b) as Registered Boy Copyists in connection with the Civil Service, may deduct from their actual age any time not exceeding five years which they may have spent in such service.

On and after the 1st July, 1901, no person will be allowed to deduct from his actual age more than two years for the purpose of admission to Competitive Examinations for Clerkships in the Second Division of the Civil Service, except (1) Persons that have served in the Army or Navy, who may deduct from their actual age any time during which they have served, and (2) Members of the Militia, the Imperial Yeomanry, the Honourable Artillery Company, or the Volunteers (whether commissioned or non-commissioned), who will be allowed to deduct from their actual age any time spent on actual military service, such time being reckoned by the number of days for which they received Army pay.

3. The limits of age are 17 and 20. Candidates must be of the prescribed age on the first day of the Examination.

1. Handwriting and Orthography, including Copying Manuscript.
2. Arithmetic.
3. English Composition.
4. Précis, including Indexing and Digest of Returns.

7. Latin, or French, or German (translation from and into the language).
8. Elementary Mathematics, viz. :—Euclid, Books I-IV, and Algebra up to and including the Binomial Theorem.
9. Inorganic Chemistry, with Elements of Physics.

N.B.—*Not more than four of the subjects numbered 4 to 9 may be offered.*

5. Application for permission to attend an Examination must be made at such times and in such manner as the Civil Service Commissioners may appoint.

6. A fee of £2 will be required from every Candidate attending an Examination.
