And whereas the Right Honourable Walter Hume Long, M.P., as lord or owner of the said Fair and the tolls thereof, has consented in writing that the said Fair should be abolished :

Now therefore I, as the Secretary of State for the Home Department, in exercise of the powers vested in me by "The Fairs Act, 1871," do hereby order that the Fair which has been annually held on the 27th and 28th days of July, in the Marketplace of Melksham, shall be abolished.
