## WILD BIRD (ENGLAND).

. The Wild Birds Protection (Administrative County of Westmorland) Order, 1900. Dated 18th May, 1900.

IN pursuance of the powers conferred on me by the Wild Birds Protection Act 1894, and upon application by the Council of the Administrative County of Westmorland, I hereby make the following Order:-

Title.

I. This Order may be cited as "The Wild Birds Protection (County of Westmorland) Order, 1900."

Certain Eggs protected throughout the County. II. The taking or destroying of the eggs of the following species of Wild Birds is prohibited throughout the County of Westmorland:

Barn Owl, Brown or Wood Owl, Long-eared

Owl, Short-eared Owl, Common Buzzard, Merlin, Kestrel, Goldfinch, Peregrine Falcon, Kingfisher, Dotterel, Raven, Heron, Bittern, Woodcock, Dipper or Water Ouzel, Golden Plover, Sheldrake, and Lesser Blackbacked Gull.

Repeal of former Order.
III. The Order of the 29th May, 1895, is hereby repealed.

## WILD BIRD (ENGLAND).

The Wild Birds Protection (Parts of Lindsey, Lincolnshire) Order, 1900.

Dated 18th May, 1900.

IN pursuance of the powers conferred on me by the Wild Birds Protection Acts, 1880 to 1896, and upon application by the County Council of the Administrative County of the Parts of Lindsey, Lincolnshire, I hereby make the following Order :-

I. This Order may be cited as "The Wild Birds Protection (Parts of Lindsey, Lincolnshire) Order, 1900."

BIRDS.

Close Time varied.

II. The time during which the killing or taking of Wild Birds is prohibited by the Act of 1880 shall be varied within the Administrative County of the Parts of Lindsey, Lincolnshire, so as to be from the 15th day of March to the 31st day of August in each year, both days inclusive.

Additions to the Schedule of the Act of 1880.

III. The Wild Birds Protection Act, 1880, shall apply within the Administrative County of the Parts of Lindsey, Lincolnshire, to the following species of Wild Birds, in the same manner as if those species were included in the schedule to the Act:-

Kestrel, Merlin, Hobby, Common Buzzard, Honey Buzzard, Swallow, House Martin, Sand Martin, Swift, Wryneck.

Certain Birds protected during the whole of the Year.

IV. During the period from the 1st day of September in any year to the 14th day of March following, both days inclusive, the killing or taking of the following species of Wild Birds is prohibited throughout the Administrative County of the Parts of Lindsey, Lincolnshire: - Nightingale, Swallow, House Martin, Sand Martin, Goldfinch, Woodpeckers (all species), Kingfisher, Owls (all | or things, viz.:-

species), Tern, Reeve or Ruff, Great Crested Grebe, Wagtails (all species), Oyster Catcher.

Eggs.

Certain Eggs protected throughout the County.

V. The taking or destroying of the eggs of the following species of Wild Birds is prohibited throughout the Administrative County of the Parts of Lindsey, Lincolnshire:-

Goldfinch, Kingfisher, Nightjar, Nightingale, Owls (all species), Ruff or Reeve, Woodpeckers all species), Kestrel, Merlin, Hobby, Common Buzzard, Honey Buzzard, Swallow, House Martin, Sand Martin, Swift, Wryneck, Teal, Wild Ducks (all species), Cuckoo, Woodcock, Wagtails (all species), Snipe.

Other Eggs protected within a certain Area.

VI. The taking or destroying of the eggs of the following species of Wild Birds is prohibited throughout the undermentioned area within the Administrative County of the Parts of Lindsey, Lincolnshire, namely: the sea coast, sandhills, dunes, waste lands, fitties, foreshore, and warrens situate between the sea and the land side of the sea wall, embankment, ditch, quick fence, or other artificial boundary separating the same from the cultivated land :-

Sheldrake, Seapie or Oyster Catcher, Ringed Dotterel, Arctic Tern, Common and Lesser Terns, Redshank, and Common Sandpiper.

Repeal of former Orders.

VII. The Orders of the 3rd August, 1881, 10th May, 1895, and 24th March, 1896, are hereby repealed.
