contravention as aforesaid, and the occupier of the place from which the animal is moved, shall, each according to and in respect of his own acts and defaults, be deemed guilty of an offence against the Act of 1894.

(2.) If a person in charge of an animal being moved, where under this Order a Movement Licence is necessary, on demand made under this Order, fails to give his true name and address, or gives a false name or address, he shall be deemed guilty of an offence against the Act of 1894.

(3.) If any person with a view to unlawfully evade or defeat the operation of this Order allows a head of cattle or a sheep or goat or pig to stray, he shall be deemed guilty of an offence against the Act of 1894.

Interpretation.

9. In this Order-

"The Act of 1894" means the Diseases of Animals Act, 1894:

"The Board" means the Board of Agriculture: "Animal" includes cattle, sheep, goats, and swine.

Other terms have the same meaning as in the Act of 1894.

Revocation of Orders.

10. The Orders described in the Second Schedule to this Order are hereby from and after the com-

mencement of this Order revoked: Provided that such revocation shall not invalidate or make unlawful anything done under the Orders hereby revoked, or affect any licence or authority granted, or any right, title, obligation, or liability accrued thereunder before the commencement of this Order, or interfere with the institution or prosecution of any proceeding in respect of any offence committed against, or any penalty incurred under, the Orders hereby revoked before the commencement of this Order.

Commencement.

11. This Order shall come into operation on the thirtieth day of May, one thousand nine bundred.

Short Title.

12. This Order may be cited as the Hert-FORDSHIRE AND BEDFORDSHIRE (FOOT-AND-MOUTH DISEASE) ORDER OF 1900 (No. 2).
