THE Board of Trade have received, through the Secretary of State for Foreign Affairs, a copy of a Despatch from Her Majesty's Minister at The Hague, reporting that the Netherlands Government have by a Decree, dated the 23rd April last, made the following modification in the Regulations

with regard to the sale of fish at the Port of Ymuiden, as enacted by the Royal Decree of 25th March, 1899 :-

The original Article 22 of the Regulations was as follows :

"The sale of fish takes place in public in the fish market and is conducted by the officials appointed for that object by the proper authority. In this Regulation shell-fish and crustaceans shall be treated as identical with fish.

"In the fishermen's harbour it is prohibited without the permission of the Director

"(a.) To buy or sell fish in any other way. (b.) To convey fish for sale otherwise than from the vessels to the fish market or to the buyers after the sale."

The same Article as modified by the new Decree runs thus :-

"The public sale of fish takes place through officials appointed for that purpose by Government and in accordance with regulations to be settled by the Minister.

"It is forbidden to sell fish in public in other manner than the above within the limits of the fishery harbour. Shell-fish as well as crustaceans shall be considered as ' fish ' in these Regulations."

The effect of the modification appears to be that the private fish salesman can, if he chooses to do so, carry on his business independently of the Government Salesmaster, provided always that no public auction of fish may be held within the limits of the fishery harbour except through that official.
