to the patrons and to the Incumbents of the four cures out of which it is intended that the district recommended in such scheme to be constituted shall be taken, and such patrons and Incumbents have respectively signified their assent to such scheme:

And whereas the said scheme has been approved by Her Majesty in Council: now, therefore, Her Majesty, by and with the advice of Her said Council, is pleased hereby to ratify the said scheme, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts; and Her Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said diocese of A. W. FitzRoy. Manchester.

WHEREAS the Ecclesiastical Commissioners for England have in pursuance of the Act of the eighth and ninth years of Her Majesty, chapter seventy; of the Act of the fourteenth and fifteenth years of Her Majesty, chapter ninetyseven; and of the Act of the nineteenth and twentieth years of Her Majesty, chapter fiftyfive; duly prepared and laid before Her Majesty in Council a representation, bearing date the twenty-sixth day of July in the year one thousand nine hundred in the words following; that is to

say:—
"We, the Ecclesiastical Commissioners for England, in pursuance of the Act of the eighth and ninth years of Your Majesty, chapter seventy, of the Act of the fourteenth and fifteenth years of Your Majesty chapter ninety-seven, and of the Act of the nineteenth and twentieth years of Your Majesty, chapter fifty-five, have prepared, and now humbly lay before Your Majesty in Council the following representation as to the assignment of a consolidated chapelry to the consecrated church of All Saints situate at East Finchley within the limits of the new parish (sometime chapelry district) of the Holy Trinity, Finchley, in the county of Middlesex and in the diocese of London.

"Whereas at certain extremities of the said new parish of the Holy Trinity Finchley and of the new parish (sometime chapelry district) of Saint James Muswell Hill in the county and diocese aforesaid which said extremities lie contiguous one to another, and are described in the Schedule hereunder written, there is collected together a population which is situate at a distance from the several churches of such new parishes respectively.

"And whereas it appears to us to be expedient that certain contiguous portions (being the portions containing the population aforesaid) of the said new parish of the Holy Trinity Finchley and of the said new parish of Saint James Muswell Hill should be formed into a consolidated chapelry for all ecclesiastical purposes, and that the same should be assigned to the said church of All Saints situate at East Finchley as aforesaid.

"Now, therefore, with the consent of the Right Honourable and Right Reverend Mandell, Bishop of the said diocese of London as such Bishop

Trinity Finchley and of the vicarage of the new parish of Saint James Muswell Hill aforesaid (in testimony whereof he the said Bishop has signed and sealed this representation) we, the said Ecclesiastical Commissioners for England, humbly represent, that it would, in our opinion, be expedient that all those contiguous portions of the said new parish of the Holy Trinity Finchley and of the new parish of Saint James Muswell Hill aforesaid which are described in the Schedule hereunder written, all which portions, together with the boundaries thereof, are delineated and set forth on the map or plan hereunto annexed, should be united and formed into one consolidated chapelry for the said church of All Saints situate at East Finchley as aforesaid, and that the same should be named 'The Consolidated Chapelry of All Saints East Finchley.'

"We, therefore, humbly pray that Your Majesty will be graciously pleased to take the premises into Your Royal consideration and to make such Order in respect thereto as to Your Majesty in Your Royal wisdom shall seem meet.

"The SCHEDULE to which the foregoing

Representation has reference.

"The Consolidated Chapelry of All Saints, East Finchley, comprising:

"All those contiguous portions of the new parish (sometime chapelry district) of the Holy Trinity Finchley and of the new parish (sometime chapelry district) of Saint James Muswell Hill, both in the county of Middlesex and in the diocese of London which are comprised within and are bounded by an imaginary line commencing upon the boundary which divides the said new parish of Saint James Muswell Hill from the new parish of the Holy Trinity Finchley at a point at the south-eastern corner of the Saint Pancras Cemetery at the eastern end of the wall or fence forming the southern boundary of the same cemetery and extending thence westward along the said wall or fence for a distance of thirty-two chains or thereabouts to its western end on the eastern side of the Great North-road and extending thence first westward to and then south-eastward along the middle of the last-named road for a distance of fifty-four chains or thereabouts to its junction with Barousmere-road and extending thence eastward along the middle of the last-named road for a distance of nine and a half chains or thereabouts to the present eastern end of the same road and continuing thence still eastward and in a direct line for a distance of eight and a half chains or thereabouts to the present western end of Southern-road and continuing thence still eastward along the middle of the last-named road for a distance of eight chains or thereabouts to its junction with Eastern-road and extending thence northward along the middle of the last-named road for a distance of fourteen chains or thereabouts to its junction with Fortis Green-road and extending thence in a direction due north and in a straight line for a distance of twenty-five chains or thereabouts across the last-named road across the grounds belonging to the house called Lynton Grange and across part of Coldfall Wood to a point in the middle of the course of the intended new road to be called Creighton-avenue and extending thence westward along the middle of the course of said intended new road for a distance of fourteen and a half chains or thereabouts to the point where it crosses the boundary which divides the said new parish of Saint James Muswell Hill from the new parish of the Holy Trinity Finchley aforesaid and extending thence northward along the said and also as the patron in right of his See both of boundary for a distance of sixteen chains or there-the vicarage of the said new parish of the Holy abouts to the first described point at the south-
