

in the description of Belmont Ward thence proceeding in a north-easterly northerly and easterly direction and following the western and northern boundaries of Belmont Ward to the boundary of the parish of Exeter thence following the boundary of the said parish in a northerly and north-westerly direction to the point in the centre of Pennsylvania-road at Mary Pole Head mentioned in the description of Rougemont Ward thence in a southerly direction and following the eastern boundary of Rougemont Ward to the point in the centre of the road at East Gate mentioned in the description of Rougemont Ward thence in a north-easterly direction along the centre of East Gate and the centre of Sidwell-street to the point of commencement of this Ward and I determine that the name of this Ward is Saint James's Ward.

"Number 10 or Saint Sidwell's Ward.

"I determine that Number 10 or Saint Sidwell's Ward shall consist of so much of the parish of Exeter as is bounded by a line commencing at a point in the centre of Heavitree-road where a line drawn along the centre of Denmark-road cuts Heavitree-road thence proceeding in a westerly direction along the centre of Heavitree-road to a point in the centre of the road at the junction of Heavitree-road and Paris-street thence in a westerly direction along the centre of Paris-street to a point in the centre of Sidwell-street opposite the centre of Paris-street thence in a north-easterly direction along the centre of Sidwell-street to the point at the junction of Black Boy-road Sidwell-street and Old Tiverton-road thence along the centre of Black Boy-road to a point in the said road opposite the centre of Grosvenor-place thence in a south-easterly direction along the centre of Grosvenor-place to a point in the centre of Belmont-road opposite Grosvenor-place thence in a north-westerly direction along the centre of Belmont-road to a point in the centre of the said road opposite the centre of Parr-street thence in a south-westerly direction along the centre of Parr-street to a point in the centre of Summerland-street opposite the centre of Parr-street thence along the centre of Summerland-street in a south-easterly direction to a point in the centre of Clifton-road at the junction of Clifton-road and Summerland-street thence along the centre of Clifton-road to the point of commencement of this Ward and I determine that the name of this Ward is Saint Sidwell's Ward.

"Number 11 or Saint Petrock's Ward.

"I determine that Number 11 or Saint Petrock's Ward shall consist of so much of the parish of Exeter as is not contained in any of the Wards whose boundaries have hereinbefore been determined and described and I determine that the name of this Ward is Saint Petrock's Ward.

"Number 12 or Saint Thomas's Ward.

"I determine that number 12 or Saint Thomas's Ward shall consist of so much of the parish of Saint Thomas as is bounded by a line commencing at a point in the centre of Cowick-street where a line drawn along the centre of Buller-road cuts the said street thence proceeding in a north-westerly direction along the centre of Buller-road to a point in the centre of the said road opposite the centre of Cleveland-street thence in a north-easterly direction along the centre of Cleveland-street to a point in the centre of Albion-street opposite Cleveland-street thence in a north-westerly direction along the centre of Albion-street to the footway leading into Okehampton-road thence along the centre of the said footway to a point in the centre of

the Okehampton-road opposite the centre of such footway thence to the centre of the track of the Great Western Railway immediately over Okehampton-road thence along the centre of the said track in a northerly direction to a point where the same cuts the boundary of the parish of Saint Thomas thence along the said boundary in a southerly, south-easterly, north-westerly, westerly, northerly and westerly direction to the point where the said boundary completely cuts the said railway track and leaves it in a south-westerly direction thence in a north-westerly direction along the centre of the said railway track to a point in the centre of the roadway underneath the railway bridge at the junction of Queen's-road and Alphington-road thence in a southerly direction to a point in the centre of the road opposite the centre of Queen's-road thence in a westerly and southerly direction along the centre of Queen's-road to a point in the said road opposite the centre of Sydney-road thence in a westerly direction along the centre of Sydney-road to a point in the centre of the said road opposite the centre of Union-street thence in a northerly direction along the centre of Union-street to a point in the said street opposite the centre of School-road thence along the centre of School-road to a point in the centre of Beaufort-road opposite School-road thence in a north-westerly direction along the centre of Beaufort-road to a point in the centre of Church-road thence in a south-westerly north-westerly and south-westerly direction along the centre of Church-road to a point in the centre of Cecil-road opposite Church-road thence in a north-westerly direction along the centre of Cecil-road to the point of commencement of this Ward and I determine that the name of this Ward is Saint Thomas's Ward.

"Number 13 or Cowick Ward.

"I determine that Number 13 or Cowick Ward shall consist of so much of the parish of Saint Thomas as is bounded by a line commencing at a point in the centre of Cowick-street where a line drawn along the centre of Buller-road cuts the said street thence proceeding easterly and following the boundary of Saint Thomas's Ward along Cecil-road, Church-road, Beaufort-road, School-road, Union-street, Sydney-road, Queen's-road, Alphington-road and along the track of the Great Western Railway to the point where the boundary of the parish of Saint Thomas completely cuts the said railway track and leaves it in a south-westerly direction as mentioned in the description of Saint Thomas's Ward thence following the boundary of the parish of Saint Thomas in a south-westerly and north-westerly direction to a point in the centre of Dunsford-road thence in a north-easterly direction along the centre of Dunsford-road and along the centre of Cowick-street to the point of commencement of this Ward and I determine that the name of this Ward is Cowick Ward.

"Number 14 or Exwick Ward.

"I determine that Number 14 or Exwick Ward shall consist of so much of the parish of Saint Thomas as is not contained in Saint Thomas's Ward or Cowick Ward hereinbefore described and I determine that the name of this ward is Exwick Ward.
