THE Board of Trade have received, through the Secretary of State for Foreign Affairs, a copy of a Despatch from Her Majesty's Representative at Brussels, intimating that the Sanitary Commission of the Scheldt has withdrawn the measures which it had provisionally imposed on arrivals from Greenock, and that vessels arriving at Antwerp from that port will only be required in future to produce a bill of health and to undergo a sanitary visit.
