Rubjerg Knude Light—Date of Exhibition.

WITH reference to Notice to Mariners No. 322 of 1900:—

The Danish Government has given further notice, that on 27th December, 1900, a 2nd order, dioptric, white flashing and group flashing light will be exhibited on Rubjerg Knude.

Rubjerg Knude Light will show a single flash and group of two flashes in a period of about thirty seconds, thus:—flash one-fifth of a second; eclipse, fourteen seconds; flash, one-fifth of a second; eclipse, one and two-fifths of a second; flash, one-fifth of a second; eclipse, fourteen seconds. It is elevated 287 feet above high water, visible, in clear weather, from a distance of 23 miles, and shown from a white rectangular tower 72 feet high.

Approximate position on Chart No. 2842a, lat. 57° 27' N., long. 9° 47' E.

Also, that a fog siren, which, during thick or foggy weather, will give single and double blasts about every minute, in the following order:—blast, two seconds; silent interval, fifty-six seconds; blast, two seconds; silent interval, fifty-six seconds; blast, one second; silent interval, four seconds; blast, one second; silent interval, fifty-six seconds.

On the same date the Rubjerg Beacon will be removed.

INSTRUMENT substituting the New Church of All Saints, situate within the New Parish of Gwynfe, in the County of Carmarthen, and in the Diocese of Saint David's, for the Old Church of the said New Parish situate within and hitherto being the Parish Church of the same New Parish.

To all to whom these presents shall come, the Ecclesiastical Commissioners for England send greeting:

WHEREAS a new church has lately been built within the new parish of Gwynfe, in the county of Carmarthen, and in the diocese of Saint David's, and has been consecrated and dedicated to All Saints.

And whereas the Right Reverend John, Bishop of the said diocese of Saint David's, as such Bishop, the Reverend William Rees, Clerk in Holy Orders, Vicar or Incumbent of the vicarage of the parish of Llangadock, in the said county and diocese, as the patron (in right of his vicarage) of the vicarage of the said new parish of Gwynfe, and the Reverend John Jones Clerk in Holy Orders, as the Vicar or Incumbent of the lastly-named vicarage, have, by an instrument under their hands, bearing date on or about the twenty-third day of November, in

the year one thousand eight hundred and ninety-nine, certified to us, the said Ecclesiastical Commissioners for England, that it would be for the convenience of the said new parish of Gwynfe, that the said new church of All Saints, situate within such new parish, should be substituted for the old parish church of the same new parish.

Now, therefore, we, the said Ecclesiastical Commissioners for England, in exercise and execution of the power or authority in that behalf contained in the Act of the eighth and ninth years of Her present Majesty, chapter seventy, and in the Act of the nineteenth and twentieth years of Her said Majesty, chapter fifty-five, and of all other powers or authorities in anywise enabling us in the same behalf, do, by this instrument under our common seal, with the consents (testified as hereinafter mentioned) of the said John Bishop of the said diocese of Saint David's, and of the said William Rees and John Jones, hereby declare that the said new church of All Saints, situate within the said new parish of Gwynfe, and duly consecrated as aforesaid, shall be, and the same is hereby substituted for, the said old parish church of the same new parish, and that such new church shall henceforth be the parish church of the said new parish of Gwynfe, in lieu of the said old parish church of the same new parish, as fully in all respects as if the said new church of All Saints, so hereby substituted, had been originally the parish church of the same new parish.

And we, the said Ecclesiastical Commissioners for England, in further pursuance and exercise of the powers and authorities aforesaid, and with such consents as aforesaid (testified as hereinafter mentioned), do hereby transfer all the endowments, emoluments, and rights of or belonging to the said old parish church of the said new parish of Gwynfe, or of or belonging to the Vicar or Incumbent thereof, to the said new church of All Saints (now being by virtue of these presents the parish church of the said new parish of Gwynfe) and to the Vicar or Incumbent thereof and his successors for ever.

In witness whereof to these presents, we, the said Ecclesiastical Commissioners for England, have set our common seal, and the said John, Bishop of the said diocese of Saint David's, has set his hand and affixed his episcopal seal, and the said William Rees and John Jones have respectively set their hands and affixed their seals, this sixth day of December, in the year one thousand nine hundred.
