**W**HEREAS the Ecclesiastical Commissioners for England have in pursuance of the Act of the sixth and seventh years of His late Majesty King William the Fourth chapter seventy-seven of the Act of the seventh and eighth years of Her late Majesty Queen Victoria chapter ninety-four of the Act of the thirteenth and fourteenth years of Her said late Majesty chapter ninety-four, and of the Act of the thirty-second and thirty-third years of Her said late Majesty chapter ninety-four duly prepared for the purpose of being laid before Her said late Majesty in Council a scheme or representation bearing date the thirteenth day of December, in the year one thousand nine hundred, in the words following, that is to say:—

"We, the Ecclesiastical Commissioners for England acting under the provisions of the Act of the sixth and seventh years of His late Majesty King William the Fourth chapter seventy-seven, of the Act of the seventh and eighth years of Your Majesty chapter ninety-four, of the Act of the thirteenth and fourteenth years of Your Majesty, chapter ninety-four, and of the Act of the thirty-second and thirty-third years of Your Majesty, chapter ninety-four, have prepared and now humbly lay before Your Majesty in Council the following scheme or representation for altering the boundaries of the new parish of Tredegar situate in the county of Monmouth and in the diocese of Llandaff.

"Whereas under the authority of an Order of Your Majesty in Council bearing date the fifteenth day of June in the year one thousand eight hundred and forty and published in the London Gazette on the twenty-fifth day of August following a certain part of the parish of Bedwelty in the said county of Monmouth and in the diocese of Llandaff aforesaid was assigned as a district chapelry to the consecrated chapel called Tredegar Chapel and such district chapelry was named the Tredegar District.

"And whereas the said Tredegar district has under the provisions of the Act of the nineteenth and twentieth years of Your Majesty chapter one hundred and four become a new parish of the character contemplated by the Act of the sixth and seventh years of Your Majesty chapter thirty-seven and by the above-mentioned Act of the thirty-second and thirty-third years of Your Majesty, chapter ninety-four.

"And whereas it has been represented to us and it appears to us to be expedient that the boundaries of the said new parish of Tredegar should be altered so as to include within its limits a certain portion of the parish of Llangynidr in the county of Brecknock and in the diocese of Saint Davids.

"Now therefore with the consents of the Right Reverend Richard Bishop of the said diocese of Llandaff and of the Right Reverend John Bishop

of the said diocese of Saint Davids (in testimony whereof they have respectively signed and sealed this scheme or representation) we the said Ecclesiastical Commissioners humbly represent recommend and propose that from and after the day of the date of the publication in the London Gazette of any Order of Your Majesty in Council ratifying this scheme or representation the boundaries of the said new parish of Tredegar shall be altered so as to include within its limits all that portion of the said parish of Llangynidr which is described in the schedule hereunder written and is delineated and set forth upon the map or plan hereunto appended and is thereon coloured pink and that from and after the same date and without any assurance in the law other than such duly gazetted Order the said portion of the said parish of Llangynidr so to be included as aforesaid shall become annexed to and become and be and shall form part of the said new parish of Tredegar and shall also become and be and form part of the said diocese of Llandaff and shall be included in the rural deanery and archdeaconry in which the said new parish of Tredegar is comprised.

"And we further represent recommend and propose that nothing herein contained shall prevent us from representing recommending or proposing any other measures relating to the matters aforesaid or any of them in accordance with the provisions of the hereinbefore mentioned Acts or any of them or any other Act of Parliament.

"The SCHEDULE to which the foregoing Scheme or Representation has reference.

"The territory to be annexed to the new parish of Tredegar in the county of Monmouth and in the diocese of Llandaff being:—

"All that portion of the parish of Llangynidr in the county of Brecknock and in the diocese of Saint Davids which is comprised within the limits of the urban district of Tredegar and of the urban district of Rhymney."

And whereas drafts of the said scheme or representation have been transmitted to the patrons and to the incumbents of the cures affected by the arrangements which are contemplated by such scheme or representation and such patrons and incumbents have respectively signified their assent thereto.

And whereas the said scheme or representation has been laid before and approved by His Majesty in Council: now, therefore, His Majesty, by and with the advice of His said Council, is pleased hereby to ratify the said scheme or representation, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts; and His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said diocese of Llandaff, and by the Registrar of the said diocese of Saint Davids.
