

Her late Majesty, intituled "The Births and Deaths Registration Act, 1874," I, Reginald MacLeod, C.B., Registrar-General of Births, Deaths, and Marriages in England, have, with the sanction of the Local Government Board, ordered and declared that on and after the 1st day of April next—

(1.) The boundary of St. George, Hanover-square Registration District shall be made identical with that of St. George, Hanover-square Poor Law Union, as it will be constituted under the provisions of the London Government Act, 1899, on and after the 25th of March, 1901;

(2.) The areas coloured green and numbered 1, 8, 10, 11, 13, 13a, 15, 17, 19, 21, and 23 on the official map of the City of Westminster, together with the detached part of St. George, Hanover-square Parish, which is wholly surrounded by Chelsea Parish, shall cease to form part of St. George, Hanover-square Registration District;

(3.) The added areas coloured red and numbered 14, 16, 18, 20, and 22 on the same map shall form part of Mayfair Sub-District;

(4.) The added areas coloured red and numbered 9 and 12 on the same map shall form part of Belgrave Sub-District; and

(5.) St. Margaret, Westminster Sub-District shall cease to be a separate Sub-District, the part thereof formerly known as Knightsbridge Hamlet shall be added to Mayfair Sub-District, to be called and known in future as Mayfair and Knightsbridge Sub-District, and the remaining part shall be added to St. John, Westminster Sub-District to be called and known in future as St. Margaret and St. John Sub-District.—Witness my hand this 26th day of February, 1901.

Stalybridge, Hyde, Mossley and Dukinfield Tramways and Electricity Board.

(Petition for additional Provision to Authorise the compulsory Purchase of Lands in the Boroughs of Stalybridge and Dukinfield for the Construction of Generating Stations.)

NOTICE is hereby given, that the Mayor, Aldermen and Burgesses of the borough of Stalybridge, the Mayor, Aldermen and Burgesses of the borough of Hyde, the Mayor, Aldermen and Burgesses of the borough of Mossley, and the Mayor, Aldermen and Burgesses of the borough of Dukinfield, the Promoters of the Bill which is now pending in

Parliament under the name or title of Stalybridge, Hyde, Mossley and Dukinfield Tramways and Electricity Board Bill (hereinafter called "the Bill"), intend to apply to Parliament by petition for additional provision for leave to introduce into the Bill clauses and provisions to effect all or some of the following purposes (that is to say):—

To empower the Board to be incorporated by the Bill (hereinafter called "the Board") to enter upon, take, and use, compulsorily or otherwise, and to hold the lands hereinafter mentioned, or some part or parts thereof, or any estates, rights, or interests in or easements over the same (that is to say):—

1. Certain lands situate partly in the borough of Stalybridge and partly in the borough of Dukinfield, both in the county of Chester, together with the buildings, reservoirs, &c., erected thereon and containing 8 acres 3 roods 265 yards or thereabouts, bounded on the north and north-easterly sides by the River Tame, on the south side by Malakoff-street, on the east side by Binn's-street, and on the west side by Sandy-lane.

2. Certain lands situate in the borough of Dukinfield, in the county of Chester, and containing 12 acres 2 roods 310 yards or thereabouts, bounded on the north side by Park-road, on the south-west side by Prospect-road, on the south-east and east sides by Sandy-lane, and on the west side by Tower-street and Pantomime Brow, and to empower the Board on such lands, or any part thereof, to erect, work, maintain, and use a station or stations for generating, transforming, and transmitting electrical energy with all dynamos, batteries, transformers, accumulators, condensers, engines, apparatus, plant, machinery, and other works, appliances and conveniences for that purpose, and to generate, transform, and transmit such energy accordingly.

To extend and make applicable to the said lands, and to any works erected thereon, all or some of the provisions contained in the Bill, with reference to the lands which by the Bill the Board are seeking power to acquire for the purpose of generating stations.

To vary and extinguish all or any existing rights and privileges connected with such lands.

Plans of the said lands, together with a book of reference thereto, and a copy of this Notice as published in the London Gazette, will, on or before the fifth day of March, 1901, be deposited for public inspection with the Clerk of the Peace for the county of Chester at his office at Chester, and with the Town Clerks of the boroughs of Stalybridge and Dukinfield at their respective offices.
