W HEREAS the Ecclesiastical Commissioners for England have in pursuance of the Act of the eighth and ninth years of Her late Majesty Queen Victoria, chapter seventy; of the Act of the fourteenth and fifteenth years of Her said late Majesty, chapter ninety-seven; and of the Act of the nineteenth and twentieth years of Her said late Majesty, chapter fifty-five; duly prepared and laid before His Majesty in Council a representation, bearing date the thirty-first day of January in the year one thousand nine hundred and one in the words and figures tollowing: that is to say,

"We the Ecclesiastical Commissioners for England in pursuance of the Act of the eighth and ninth years of Her late Majesty Queen Victoria, chapter seventy, of the Act of the fourteenth and fifteenth years of Her said late Majesty chapter

ninety-seven, and of the Act of the nineteenth and twentieth years of Her said late Majesty chapter fifty-five, have prepared and now humbly lay before Your Majesty in Council the following representation as to the assignment of a consolidated chapelry to the consecrated church of Saint Barnabas Little Ilford situate in Browning-road in the parish of Little Ilford in the county of Essex, and in the diocese of Saint Albans.

"Whereas at certain extremities of the said parish of Little Ilford, and of the parish of East Ham in the county and diocese aforesaid which said extremities lie contiguous one to another, and are described in the schedule hereunder written, there is collected together a population which is situate at a distance from the several churches of such parishes respectively.

"And whereas it appears to us to be expedient that certain contiguous portions (being the portions containing the population aforesaid) of the said parish of Little Ilford and of the parish of East Ham aforesaid should be formed into a consolidated chapelry for all ecclesiastical purposes, and that the same should be assigned to the said church of Saint Barnabas Little Ilford situate as aforesaid.
