"Ten days' quarantine imposed on arrivals from Bittlis at Sulina, also prohibition to import following articles:—used body linen, wearing apparel and bedding, rags, not excepting those pressed by hydraulic power, transported as merchandise, used sacks, carpets, used embroideries, raw leather, untanned hides, fresh skins, horse-hair, human hair, wool, cotton, cordage, fruit, vegetables, preserves."
