

with great advantage be more conveniently served by the incumbent of Llangeinor who resides in the valley where the bulk of such population is resident, whereas the incumbent of Llandyfodwg resides in his parish at a distance of about four miles therefrom, and consequently it would be to the religious interest of the population there situate that the portion so edged red upon the plan should be separated from the said parish of Llandyfodwg and annexed to the said parish of Llangeinor for ecclesiastical purposes thus enabling the incumbent of Llandyfodwg to concentrate his energies upon that portion of his parish in which he is so resident.

"4. It appears to us the said Bishop of Llandaff, and we do hereby represent that under the provisions of the Pluralities Acts 1838 and 1887 the portion of the said parish of Llandyfodwg hereinbefore referred to may be advantageously separated from the parish to which the same now belongs and be annexed to the parish of Llangeinor and the following is the detailed description thereof:—

"The boundary of the new portion of the parish of Llandyfodwg to be taken over to Llangeinor Parish starts from a point which is called Crug yr Afan (where the four parishes of Llangynwyd, Llangeinor, Ystradyfodwg and Llandyfodwg meet). The line then proceeds in a south-easterly direction along the present boundary of the parish of Llandyfodwg for two miles and three furlongs and it then takes a south-south-westerly direction along the ridge of the mountain, Mynydd yr Aber, for a distance of about four miles to the west side of the Homestead Dolauthonddu and then due west to the River Ogmore which forms the present boundary of the parish of Llangeinor. It then follows the River Ogmore which at present forms the boundary between the parishes of Llangeinor and Llandyfodwg in a northerly direction right up to its source and from the source to the point called Crug yr Afan aforesaid.

"5. Emily Charlotte Talbot, of Margam Park in the county of Glamorgan, Spinster, is the patron of the benefice of Llangeinor, and John Picton Turbervill, of Ewenny Priory, in the county of Glamorgan Esquire is the patron of the benefice of Llandyfodwg.

"6. The Reverend David Phillips, Clerk, is the present incumbent of the benefice or perpetual curacy of Llangeinor, and the Reverend William Edwards, Clerk, is the present incumbent of the benefice or vicarage of Llandyfodwg.

"Pursuant to the directions contained in the twenty-sixth section of the Pluralities Act 1838 we the said Bishop of Llandaff have drawn up the scheme in writing annexed to this representation describing the portion of the parish of Llandyfodwg so as aforesaid proposed to be annexed to the parish of Llangeinor and the mode in which it appears to us that the alterations may best be effected and how the changes consequent thereon in respect of ecclesiastical jurisdiction, glebe lands, tithes, rent charges, and other ecclesiastical dues, rates, and payments and in respect of rights to pews may be made with justice to all parties interested, and we do hereby submit the same to your Grace together with the necessary consents in pursuance of the Pluralities Act 1838 of the said Emily Charlotte Talbot, Spinster, the patron of the benefice or perpetual curacy of Llangeinor, and John Picton Turbervill, the patron of the benefice or vicarage of Llandyfodwg and in case you shall upon full consideration and inquiry be satisfied therewith, we request that your Grace will be pleased to certify the same

and the consents aforesaid by your report to Her Majesty in Council."

And whereas the scheme drawn up by the said Bishop and the consents referred to in the said representation are as follows:—

#### "SCHEME.

"It is proposed to separate from the parish of Llandyfodwg all that portion of the said parish which is edged red upon the plan annexed hereto and included within a boundary commencing at a point which is called Crug yr Afan (where the four parishes of Llangynwyd, Llangeinor, Ystradyfodwg and Llandyfodwg meet). The line then proceeds in a south-easterly direction, along the present boundary of the parish of Llandyfodwg for two miles and three furlongs, and it then takes a south-south-westerly direction along the ridge of the mountain Mynydd yr Aber for a distance of about four miles to the west side of the homestead Dolauthonddu, and then due west to the River Ogmore, which forms the present boundary of the parish of Llangeinor. It then follows the River Ogmore which at present forms the boundary between the parishes of Llangeinor and Llandyfodwg in a northerly direction right up to its source and from the source to the point called Crug yr Afan aforesaid.

"The Incumbent of the parish of Llangeinor shall have exclusive cure of souls within the limits of the portion of the said parish so proposed to be separated from the parish of Llandyfodwg and annexed to the parish of Llangeinor, and which shall be subject to the same ecclesiastical jurisdiction as the said parish of Llangeinor, and all the fees for churchings, marriages and burials and other ecclesiastical offices solemnized or performed at the church or churchyard of the parish of Llangeinor in respect of the inhabitants of the district so proposed to be annexed thereto shall belong to and continue to be received by such Incumbent of Llandyfodwg for the time being.

"Nothing in the said scheme is to prejudice the rights of the present Incumbent of Llandyfodwg legally entitled to the fees hereinbefore referred to except with the consent of such Incumbent.
