"That there are in the county of Glamorgan and his diocese of Llandaff the perpetual curacy of Llangeinor and the vicarage of Llandyfodwg.

"That it appears to the said Lord Bishop that a certain district being a portion of the parish of Llandyfodwg may be advantageously separated from the said parish of Llandyfodwg and annexed to the contiguous parish of Llangeinor for ecclesiastical purposes only under the provisions

of the Pluralities Acts 1838 and 1887.

"That pursuant to the directions contained in the said Acts, the said Lord Bishop has drawn up a scheme in writing describing the mode in which it appears to him that the proposed alteration may best be effected and how the changes consequent upon such alteration in respect to ecclesiastical jurisdiction, glebe lands, tithes, rent charges and other ecclesiastical dues rates and payments and in respect to patronage and rights to pews may be made with justice to all parties interested which scheme together with the consents thereto in writing of Emily Charlotte Talbot of Margam Park in the county of Glamorgan Spinster as the patron or person entitled to present to the said benefice of Llangeinor in case the same were now vacant and John Picton Turbervill of Ewenny Priory in the county of Glamorgan Esquire as the patron or person entitled to present to the said benefice of Llandyfodwg in case the same were now vacant and of the Reverend David Phillips Incumbent of the benefice or perpetual curacy of Llangeinor in the county of Glamorgan and the Reverend William Edwards, Clerk, Vicar of Llandyfodwg in the same county both in the diocese of Llandaff has been transmitted to us by the said Lord Bishop for our consideration.

"The representation and scheme of the said Lord Bishop and the consents before referred to

are hereunto annexed.

"And we the said Archbishop being on full consideration and enquiry satisfied with the said scheme do hereby pursuant to the said Pluralities Act 1838 certify the same and such consents as aforesaid to Your Majesty in Council to the intent that Your Majesty in Council may in case Your Majesty in Council shall think fit so to do make and issue an Order for carrying the said scheme into effect.

Now therefore His Majesty in Council by and with the advice of His said Council is pleased to order as it is hereby ordered that the said scheme be carried into effect.

> (No. 5493.) Quarantine. Plague.

Under the power and authority vested in him by the "Quarantine Ordinance, 1879," His Excellency the High Commissioner orders that all direct arrivals from Smyrna and any port or place on the coast of Asia Minor from Dikeli to Yeronda, inclusive, be subjected to 24 hours' quarantine of observation to be undergone at Larnaca, and that the importation of very susceptible goods, i.e., rags, worn clothing, and empty used sacks, except gypsum sacks, is prohibited.
