I hereby order that all vessels arriving from the said place shall be placed in quarantine, and that no person or thing shall be relieved from quarantine until released by the Colonial Surgeon and approved by the Governor, and it is further ordered that no licensed trader or bumboatman shall be permitted to board or go alongside any passing vessel from the aforesaid place.

Any person contravening any of the foregoing restrictions shall be liable to the penalties laid down in Her Majesty's Order in Council dated 11th July, 1839.
