WE, the Ecclesiastical Commissioners for England, in consideration of a benefaction of one hundred pounds sterling which has been paid to us in favour of the consolidated chapelry and benefice (hereinafter called the benefice) of Saint Aidan, Bamber Bridge, in the county of Lancaster, and in the diocese of Manchester, and in respect of which we have agreed to pay to the Incumbent of the same benefice, and to his successors, a yearly sum of three pounds, do hereby, in pursuance of the Act of the twenty-ninth and thirtieth years of Her late Majesty Queen Victoria, chapter one hundred and eleven, section five, grant out of our common fund to the said benefice of Saint Aidan, Bamber Bridge, to meet such benefaction, one other capital sum of one hundred pounds, in respect of which, so long as the same capital sum or any part thereof shall remain in our hands, there shall be paid by us to the Incumbent for the time being of the said benefice one other yearly sum of three pounds, or such part thereof as shall be proportionate to any balance of the same capital sum which shall so remain in our hands; such lastly-mentioned yearly payment to commence as from the date of the publication of these presents in the London Gazette, and to be receivable in equal quarterly portions on the first day of February, the first day of May, the first day of August, and the first day of November in each and every year.

In witness whereof, we have hereunto set our common seal, this second day of May, in the year one thousand nine hundred and one.
