Trieste, 4th May, 1901. The Imperial and Royal Ministry of Commerce has, by decree of 1st May, 1901, No. 1741/H.M., ordered that henceforth all arrivals from Alexandria (Egypt), if provided with clean bills of health, will undergo only medical inspection (ordered by Government Decree of December 1899, No. 14968, against arrivals from Turkey,

Greece, and North Africa). Should however, arrivals from Alexandria not be provided with clean bills of health, the respective vessels will have to be treated according to Government Circular of 5th November, 1900, No. 13835.
