Now therefore, We, the Local Government Board, in the exercise of the powers given to Us by the Statutes in that behalf, by this Our Order Direct that, so far as the above-cited General Orders relate to the said Holborn Union, Article 84 of the said General Order dated the twenty-fourth day of July, one thousand eight hundred and fortyseven, shall have effect as if for the words "the presiding Chairman and two other Guardiaus" there were substituted therein the words "three Guardians," and Article I of the said General Order dated the seventh day of April, one thousand eight hundred and fifty-seven, and the Form in the said Article mentioned shall have effect as if the words "Presiding Chairman" were omitted from the said Form, and the said Form were otherwise modified and adapted so as to provide for the insertion therein of the signatures of the three Guardians by whom, in pursuance of this Order, the order drawn upon the Treasurer may be signed.
