The KING's Most Excellent Majesty in Council.

WHEREAS the Ecclesiastical Commissioners for England have in pursuance of the Act of the seventh and eighth years of Her late Majesty Queen Victoria, chapter ninety-four; of the Act of the thirteenth and fourteenth years of Her said late Majesty, chapter ninety-four, and of the Act of the thirty-second and thirty-third years of Her said late Majesty, chapter ninetyfour, duly prepared and laid before His Majesty in Council a scheme or representation, bearing date the eighteenth day of July, in the year one thousand nine hundred and one, in the words following, that is to say:—

"We, the Ecclesiastical Commissioners for England, acting under the provisions of the Act of the seventh and eighth years of Her late Majesty Queen Victoria chapter ninety-four, of the Act of the thirteenth and fourteenth years of Her said late Majesty chapter ninety-four, and of the Act of the thirty-second and thirtythird years of Her said late Majesty chapter ninety-four, have prepared and now humbly lay before Your Majesty in Council the following scheme or representation for altering the boundaries of the new parish of Christ Church West Hartlepool and of the new parish of Saint Paul West Hartlepool both in the county of Durham and in the diocese of Durham.

"Whereas by the authority of an Order of Her said late Majesty in Council bearing date the eleventh day of January in the year one thousand eight hundred and fifty-ninc and published in the London Gazette upon the eighteenth day of the same month a part of the parish of Stranton in the said county of Durham and in the diocese of Durham aforesaid was assigned as a district chapelry to the consecrated church called Christ Church situate at West Hartlepool within the limits of the said parish of Stranton and the same district chapelry was called 'The District Chapelry of Christ Church West Hartlepool.'

"And whereas by the authority of another Order of Her said late Majesty in Council bearing date the twenty-sixth day of June in the year one thousand eight hundred and eighty-six and published in the London Gazette on the second day of July following a part of the said parish of Stranton was assigned as a district chapelry to the consecrated church of Saint Paul situate at West Hartlepool in the said parish of Stranton and the same district chape'ry was called 'The District Chapelry of Saint Paul West Hartlepool.'

"And whereas the said district chapelry of Christ Church West Hartlepool and the said district chapelry of Saint Paul West Hartlepool have each of them under the provisions of the Act of the nineteenth and twentieth years of Her said late Majesty chapter one hundred and four, become a new parish of the character contemplated by that Act and by the Act of the sixth and screnth years of Her said late Majesty chapter thirtyseven and by the above-mentioned Act of the thirty-second and thirty-third years of Her said late Majesty. chapter ninety-four.

"And whereas it has been represented to us and it appears to us to be expedient that the boundaries of the said new parish of Christ Church West Hartlepool and of the said new

parish of Saint Paul West Hartlepool should be altered in the manner hereinafter mentioned.

"Now therefore with the consent of the Right Reverend Brooke Foss Bishop of the said diocese of Durham (in testimony whereof he has signed and sealed this scheme or representation) we the said Ecclesiastical Commissioners humbly represent recommend and propose that from and after the day of the dute of the publication in the London Gazette of any Order of Your Majesty in Council ratifying this scheme or representation and without any assurance in the law other than such duly gazetted Order the boundaries of both of the said new parish of Christ Church West Hartlepool and of the said new parish of Saint Paul West Hartlepool shall be altered so that all that portion of the said new parish of Saint Paul West Hartlepool which is described in the first schedule hereunder written and is delineated and set forth upon the map or plan hereunto appended and is thereon coloured green shall be dissevered from such new parish and shall be annexed to and shall in future form part of the said new parish of Christ Church West Hartlepool and that in like manner all that portion of the said new parish of Christ Church West Hartlepool which is described in the second schedule hereunder written and is delineated and set forth upon the said map or plan hereunto annexed and is thereon coloured pink shall be dissevered from the last-named new parish and shall be annexed to and shall in future form part of the said new parish of Saint Paul West Hartlepool.

"And we further represent recommend and propose that nothing herein contained shall prevent us from representing recommending or proposing any other measures relating to the matters aforesaid or any of them in accordance with the provisions of the hereinbefore mentioned Acts or any of them or of any other Act of Parliament.

"The SCHEDULES to which the foregoing Scheme or Representation has reference. "THE FIRST SCHEDULE.

"The territory to be dissevered from the new parish of Saint Paul West Hartlepool in the county and diocese of Durham and to be annexed to the new parish of Christ Church, West Hartlepool, in the same county and diocese being : --

All that portion of the said new parish of Saint Paul West Hartlepool which is bounded upon the south by the parish of Stranton, in the county and diocese aforesaid upon the east and upon the north east by the said new parish of Christ Church West Hartlepool and upon the remaining side that is to say upon the west by an imaginary line commencing upon the boundary which divides the said new parish of Christ Church West Hartlepool from the new parish of Saint Paul West Hartlepool aforesaid at the point where Hart-road is joined by Lowthian-road and by Avenue-road and extending thence southward along the middle of the last-named road for a distance of twenty-five chains or thereabouts to its junction with Villiers-street and with Milllane and extending thence eastward along the middle of the last-named lane for a distance of three chains or thereabouts to its junction with Waldon-street and extending thence southward along the middle of the last-named street for a distance of four and a half chains or thereabouts to its junction with Park-read upon the boundary which divides the said new parish of Saint Paul West Hartlepool from the parish of Stranton afcresaid.

"The SECOND SCHEDULE. "The territory to be dissevered from the said new parish of Christ Church West Hartlepool and
