Privy Council Office, August 27, 1901. MERCHANT SHIPPING ACT, 1894.

OTICE is hereby given that, after the expiration of forty days from the date hereof. it is proposed to submit to His Majesty in Council, in pursuance of the above-mentioned Act, the draft of an Order in Council a proving certain Pilotage Bye-laws made by the Corporation of the Guild or Brotherhood of Masters and Pilots Seamen of Trinity House in Kingstonupon-Hull, fixing the rates to be demanded and received for Pilotage between the Ports of Hull and Goole, and for reducing the Commission formerly payable to the Pilot Master at Goole for collection of Pilotage, keeping the accounts, and general management.

And notice is hereby further given that, in accordance with the provisions of the Rules Publication Act, 1893, copies of the proposed draft Order in Council can be obtained by any public body, within forty days of the date of this notice, at the Privy Council Office, Whitehall.
