WILD BIRD (ENGLAND). The Wild Birds Protection (County of Cardigan) Order, 1901. Dated 16th September, 1901.

IN pursuance of the powers conferred on me by the Wild Birds Protection Acts, 1880 to 1896, and upon application by the County Council of the Administrative County of Cardigan, I hereby make the following Order:-

I. This Order may be cited as "The Wild Birds Protection (County of Cardigan) Order, 1901."

BIRDS.

Additions to the Schedule of the Act of 1880. II. The Wild Birds Protection Act, 1880, shall apply within the County of Cardigan to the following species of Wild Birds in the same manner as if those species were included in the Schedule to the Act:-

Kestrel, Kite, Buzzard, Peregrine Falcon, Hen Harrier, Heron, Chough, Water Ouzel.

Certain Birds protected during the whole of the Year.

III. During the period between the 31st day of July in any year and the 2nd day of March following, the killing or taking of the following species of Wild Birds is prohibited throughout the County of Cardigan :-

Bittern, Buzzard, Kite, Kestrel, Gulls (except Black-backed Gull), Heron, Chough, Spoonbill, Kingfisher, Dipper or Water Ouzel, Owls of all kinds, Wcodpeckers, Goldfinch, Linnets, Wood-lark, Skylark, Blackcap, Stone Chat, Brown Wren, Golden Crested Wren.

Certain Eggs protected throughout the County. IV. The taking or destroying of the Eggs of the following species of Wild Birds is prohibited throughout the County of Cardigan :-

Buzzard, Kite, Kestrel, Peregrine Falcon, Redbacked Shrike, Nightjar, Woodpeckers, Chough, Heron, Curlew, Gulls (except Black-backed Gull), his Commission. Dated 21st September, 1901. Oyster Catcher, Wild Duck, Teal, Sheldrake,
