- (b.) In such earthen graves as are now existing in the churchyard burials may be allowed, at or below the depth of five feet from the surface of the ground, of the bodies of any members of the family of any of the persons heretofore buried in such graves.
- (c.) In the churchyard in any grave space in which no interment has heretofore taken place the burial may be allowed, at or below the depth of five feet from the surface of the ground, of the body of any member of the family to which such grave space may be allotted.
- (d.) In the churchyard in a grave space in which no interment has heretofore taken place the burials may be allowed, at or below the depth of five feet from the surface of the ground, of the body of Mr. J. B. Fortescue and of the bodies of any members of his
