# Board of Trade (Fisheries and Harbour Department), London, October 24, 1901.

THE Board of Trade have received, through the Secretary of State for Foreign Affairs, a translation of Article 23 of a Royal Decree issued by the Netherlands Government on the 21st ultimo, in regard to special measures for the prevention of the plague.

The translation is as follows :-

ART. 23. Captains of vessels coming from countries or places declared by Our Minister of the Interior to be infected with the plague, or on board of which a case of this sickness has arisen during the last voyage, must touch at no other Netherlands ports or roads than those of Flushing, Hoek van Holland, Ijmuiden, Helder, Harlingen, Delfzijl, or those which shall be indicated later on . by Oar Minister of the Interior, and at nowhere else in the Netherlands until they have submitted their ship in one of the aforesaid harbours or in one of the aforesaid roads to the sanitary examination prescribed in the Law of 28th March, 1877 (Staatsblad No. 35).

The captain of a ship after arriving by sea, lying in the Netherlands in any other place than one of the aforesaid harbours or one of the aforesaid roads, and on which the plague is detected, is bound on the first summons of the burgomaster of the port where he is lying, or of the commune nearest to the place where he has anchored, to go away to one of the harbours or roads aforesaid, unless he prefers to go to sca again.

By the word " road " shall be understood every anchorage for ships coming from sea within the sca passages and in the rivers and streams.
