The Orders described in the Second Schedule to this Order are hereby from and after the commencement of this Order revoked: Provided that such revocation shall not invalidate or make unlawful anything done under the Swine-Fever (Infected Areas) Order of 1896 and the Orders described in the Second Schedule to this Order before the commencement of this Order, or interfere with the institution or prosecution of any proceeding in respect of any offence committed against, or any penalty incurred under, those Orders before the commencement of this Order.
