9. The Bill for the intended Act may be introduced into Parliament either on Petition as a Private Bill or on motion; and in the former case printed copies of the intended Act will on or before the 21st day of December next be deposited in the Private Bill Office of the House of Commons.

Richmond Hill (Preservation of View).
(Dedication of Lands as Public Open Spaces to secure the Preservation of the View from Richmond Hill; Vesting Petersham Meadow and other Lands in Public Authority as Open Spaces; Vesting Petersham Common and Ham Common in Public Authorities; Vesting of Land along the River Thames in Public Authority as Public Open Spaces; Exchange of Lands; Extinction of Common Rights over Ham Lammas Lands; Substitution of other Lands; Provisions for regulating Commons and Open Spaces, making Bye-laws, and giving Powers to Local Authorities; Agreements with County Councils, Corporations, District Councils, and other Authorities; Amendment of Acts and Schemes.)

NOTICE is hereby given, that application is intended to be made to Parliament, in the ensuing Session, for leave to bring in a Bill for the following purposes or some of them (that is to say):—

(1.) To make provision for protecting the view from Richmond-hill, and for preserving certain areas of land, situate in front thereof, from being used for the erection of buildings. To provide for the dedication, with that object, of certain lands known as Petersham Common, Petersham Meadows, and other lands in the parish of Petersham, and for vesting such lands in the Mayor, Aldermen, and Burgesses of the borough of Richmond, in the county of Surrey (hereinafter referred to as the Richmond Corporation), to be held by them in perpetuity as public open spaces, and to empower the Richmond Corporation to make regulations and bye-laws for the proper protection, management, and control thereof.

The lands proposed to be vested in the Richmond Corporation lie within an area bounded on the north by Nightingale-lane, on the east by Richmond Park, on the south-east by Petersham Park, on the south partly by Petersham Park and partly by the grounds of Bute House and St. Peter's Church and Vicarage, on the south-west by River-lane and the grounds of Petersham Lodge, and on the west by the River Thames.

(2.) To vest in the Urban District Council of

Ham in the county of Surrey the soil of certain lands known as Ham Common in the parish of Ham in the county of Surrey to be held in perpetuity as a public open space subject to the provisions of the Metropolitan Commons (Ham) Supplemental Act, 1901, and to give the said Council powers for the protection, management and control thereof. Ham Common is bounded on the north partly by the village of Ham and partly by Sudbrook Park, on the east by Richmond Park, on the south partly by the grounds of Latchmere House and partly by lands belonging to the Earl of Dysart, and on the west by the village of Ham.

(3.) To vest in the Surrey County Council, the Richmond Corporation, the Mayor, Aldermen, and Burgesses of the borough of Kingston-upon-Thames, the Urban District Council of Ham, or one or all of them, certain lands in the county of Surrey lying along the River Thames and including the towing path between Nightingale-lane and Richmond Ferry on the north, and a point on the bank of the River Thames known as Half Mile Tree, near the northern boundary of the borough of Kingston-upon-Thames on the south, and to dedicate such lands in perpetuity as a public promenade or open space, and to authorize and provide for the making of bye-laws by such local authorities or some of them, and conferring powers for the protection, management and control of the lands so to be vested in them.

(4.) To authorize and empower the Right Honourable Sir William John Manners, Earl of Dysart (hereinafter referred to as "the Earl of Dysart"), and the Trustees for the time being of the will dated the 26th day of June, 1873, of the late Right Honourable Sir Lionel William John Manners, Earl of Dysart (hereinafter referred to as "the Trustees"), and all or any other person or persons for the time being entitled to the said lands proposed to be dedicated as aforesaid (hereinafter referred to as "the dedicated lands") to convey the dedicated lands without payment, and to enter into any agreement or agreements as they may be advised with any County or other Council, Corporation, or public body, person or persons, as may be provided for by the Bill.

(5.) To extinguish all lammas and other rights of common whatsoever exercisable in, over, or upon all such part or parts of the lands known as the Ham Lammas Lands or Ham Fields (hereinafter called the Lammas Lands) as belong, or under any deed of sale or exchange may or shall belong to the Earl of Dysart and the Trustees or either of them. The Lammas Lands lie within an area bounded on the north-west and south-west by the River Thames, on the south by the borough of Kingston-upon-Thames, and on the east by Ham-street and Upper Ham-road.

(6.) To provide for compensation to the owners of any rights of common in respect of their extinction, or to provide that such rights shall be exercisable over other lands in substitution for the Lammas Lands, and to empower the Earl of Dysart and the Trustees to enter into any agreement or deed, and make any arrangement for the sale or exchange of a portion or portions of the Lammas Lands to or with any other owner or owners of other portions of the Ham Lammas Lands, and to empower any such other owner or owners on their part to sell or exchange, or enter into any arrangement with the Earl of Dysart and the Trustees for the sale or exchange of such respective parts of the Lammas Lands.

(7.) To provide for the release or extinction of the rights and interests of the Earl of Dysart and the Trustees in Petersham and Ham Commons.

(8.) To empower any Corporation, county or
