WHEREAS the Local Government Board, after giving to the Incumbent and the Churchwardens of the parish of All Saints, Moxley, ten days' previous notice of their intention to make such representation, have, under the provisions of the Burial Act, 1853, made a representation stating that, for the protection of the public health, no new burial-ground should be opened in the civil parish of Wednesbury without the previous approval of the Local Government Board, and that burials should be discontinued therein, as follows:—

ALL SAINTS, MOXLEY.—Forthwith and entirely in the Parish Church of All Saints, Moxley, in the county of Stafford ; and in the churchyard, except as follows, viz. :—

(a.) In any vault or walled grave now existing in the said churchyard, burial may be allowed subject to the condition that every coffin buried in such vault or grave be separately enclosed by stonework or brickwork properly cemented :

(b.) In any earthen grave now existing in the said churchyard, the burial may be allowed, at or below the depth of five feet from the surface of the ground, of the body of any member of the family of the person or persons heretofore buried in such grave:

(c.) In the said churchyard, in any grave space in which no interment has heretofore taken place, the burial may be allowed at or below the depth of five feet from the surface of the ground, of the body of any person for whom or of any member of a family for which such grave space has been reserved and appropriated as a burial place, with the exclusive right of burial therein.

Now, therefore, His Majesty in Council is pleased hereby to give notice of such representation, and to order that the same be taken into consideration by a Committee of the Lords of His Majesty's Most Honourable Privy Council on the twenty-fifth day of January next.

THE following Statutes, made on the sixth day of December, one thousand nine hundred and one, by the Governing Body of Jesus College, Oxford, have been submitted for the approval of His Majesty in Council, and notice of their having been so submitted is published in accordance with the provisions contained in "The Universities of Oxford and Cambridge Act, 1877":-

Jesus College, Oxford.

STATUTES to alter and amend the Statutes framed by the Commissioners appointed under "The Universities of Oxford and Cambridge Act 1877,' 40 and 41 Victoria cap. 48, and approved by the late Queen in Council on the third day of May, one thousand eight hundred and eighty-two, in relation to Jesus College in the University of Oxford, in particular to Statute V as amended by Statutes approved by the late Queen in Council on the twenty-fourth day of June one thousand eight hundred and eighty five and the tenth day of August one thousand eight hundred and eightyeight, and also to the Schedule relating to King Charles the First's Trust as amended by Statutes approved by the late Queen in Council on the twenty-fourth day of June one thousand eight hundred and eighty-five and on the thirteenth day of May, one thousand nine hundred and one, such amending Statutes being duly made at a general meeting of the Governing Body of the said College specially summoned for this purpose held on the sixth day of December one thousand nine hundred and one, and passed by the unanimous votes of those present and voting in accordance with Section 54 of "The Universities of Oxford and Cambridge Act 1877."

Statute V.

Clause 2. For the words "of parents who are or have been resident in Wales or Monmouthshire" substitute the words "of a father or mother who was born in Wales or Monmouthshire or who has been resident there."

Clause 3. Omit the words "no person" as far as "day of election" inclusive.

Clause 8. For the words "inclusive of rooms and all allowances" read the words "or more as the revenues of the College shall permit, but in no case shall it exceed £100 per annum."

Clause 9. After the words "Foundation Scholarships" insert the words "and Exhibitions."

Clause 10. For the words "for the purpose" as far as the word "paid" inclusive read the words "into which shall be paid, in addition to any sums accruing under clauses 5 and 6."

Omit the words "not exceeding $\pounds 150$."

For the words "in assisting such members" as far as the end "Fellows from time to time" in-
