- (ii.) Minor Exhibitions, to be awarded terminally to such members of the College in residence and receiving instruction under the direction of the College as the Principal and Fellows may deem to be in need of assistance at the Univer-No member of the College receiving instruction as aforesaid, who already holds Major Exhibition a? Scholarship or on that account be held to be ineligible to a Minor Exhibition. All Minor Exhibitions shall be tenable under such regulations as shall be made by the Principal and Fellows from time to time, but they shall in no case exceed in value fifteen pounds per term.
- (iii.) So much of the Exhibition Fund as may not be required to maintain Major and Minor Exhibitions may be applied by the Principal and Fellows in such manner as they may deem best for promoting study and improvement among the members of the College in statu pupillari."
