(f.) Hoofs and hair, raw silk, wool, and human hair, skins (raw, fresh, or untanned), when such articles arrive from infected ports.

(g.) Cotton seed arriving from countries in which anthrax is epidemic.

18. The importation is prohibited, unless the goods be accompanied by a satisfactory certificate from the British Consular Authority that Phylloxera is not known to exist in the place of origin of —

Plants or roots from any port in the Mediterraneap.

19. The importation is allowed, after disinfection, o^r--

(a.) Wearing apparel, soiled linen and clothing, articles of bedding, feathers, bones, and jute goods, whitever be the pure whence such articles may have arrived.

. (b.). Used sacks, carpets and embroideries which have been used, when such articles arrived from infected port-.

(c.) Goods which admit of being disinfected, or are not susceptible to infection, arriving on the vessels referred to in paragraphs 2, 3, and 11.

20). Cereals imported from infected ports are to be kept for twenty-one days at the lazaretto or any other place to be appointed by the C.llector of Cu-toms, to be aired under the direction of the Quara time Authorities.

1. Vessels with cargoes or goods from infected countries remain subject to the measures prescribed in Order No. 467 of the Bulgarian Minister of the Interior.

2. Vessels from infected countries carrying passengers only, with foul bills, but not having had a case of plague on board during the voyage, will receive free pratique after 11 days' quarautine and thorough inspection.

3. Passengers from infected countries are admitted into Bulgaria after five days' quarantine and steam disinfection of all their baggare, but they will be subject to 10 days' medical supervision at their place of residence.

(2.) That a certificate is produced from a British or an American Consular Officer that the vessel has not been alongside any wharf or pier at Rio de Janeiro, and that there is no case of plague in the harbour;

(3.) That a certificate is given by the Master of the vessel that the rats and other vermin on such vessel have been exterminated as far as possible before loading at Rio;

(4.) That the passengers and crew are inspected by the health officer and reported free from disease ;

(5.) That no cargo is shipped or landed and that the cargo hatchways are not removed while the vessel is alongside the wharf;

(6.) That every precaution is taken to prevent rats coming ashore from the vessel.

The Regulations passed on the 28th June, 1900, shall be read with this modification.
