

also in the churchyard; provided that in the walled grave belonging to Mrs. Riches burial may be allowed, subject to the condition that each coffin buried in such grave be separately enclosed by stonework or brickwork properly cemented.

Now, therefore, His Majesty in Council is pleased hereby to give notice of such representation, and to order that the same be taken into consideration by a Committee of the Lords of His Majesty's Most Honourable Privy Council on the twenty-fourth day of February next.

And His Majesty is further pleased to direct that this Order be forthwith published in the London Gazette, and that copies thereof be affixed on the doors of the churches or chapels of, or on some conspicuous places within, the parish affected by such representation one month before the said twenty-fourth day of February.
