IN pursuance of the powers conferred on me by the Wild Birds Protection Acts, 1880 to 1896, and upon application by the Council of the County Borough of Blackburn, I hereby make the following Order:—

Title.

I. This Order may be cited as the Wild Birds Protection (County Borough of Blackburn) Order, 1902.

BIRDS.

Additions to the Schedule of the Act of 1880.

II. The Wild Birds Protection Act, 1880, shall apply within the County Borough of Blackburn to the following species of Wild Birds in the same manner as if those species were included in the Schedule to the Act:—

Wheatear, Whinchat, Stonechat, Redstart, Robin, Hedge Sparrow, Chiffchaff, Gold Crest, Longtailed Tit, Nuthatch, Tree Creeper, Wren, Dipper or Water Ouzel, Raven, Spotted Flycatcher, Swallow, Martins, Linnet, Lesser Redpoll, Grey Wagtail, Yellow Wagtail, Corn Bunting, Reed or Blackheaded Bunting, Cirl Bunting, Tree Pipit, Meadow Pipit, Rock Pipit, Swift, Wryneck, Buzzard, Peregrine Hobby, Kestrel, Merlin, Osprey, Pied Flycatcher, Song Thrush, Blackbird, Greater Whitethroat, Lesser Whitethroat, Sedge Warbler, Reed Warbler, Blackcap Warbler, Garden Warbler, Willow Warbler, Wood Warbler, Grasshopper Warbler, Heron.

Eggs.

Certain Eggs protected throughout the County Borough.
