"writing under his or their hands to such "scheme, or to such modification thereof as the "said Archbishop may approve, and the said Arch-bishop shall, on full consideration and inquiry, "be satisfied with any such scheme, or modifica-"tion thereof, and shall certify the same and such consent as aforesaid, by his report to Her "Majesty in Council, it shall be lawful for Her " Majesty in Council to make an Order for carry-"ing such scheme, or modification thereof, as the "case may be, into effect."

And whereas by section eight of the Church Building Act, 1839, it is, amongst other things, further enacted, "That when by any Order of "Her Majesty in Council, as aforesaid, a separate "parish for ecclesiastical purposes is constituted, "the same shall, on registration thereof, and "with the consent in writing of the Incumbent " or Incumbents of the benefice or benefices to "be thereby affected, become a perpetual curacy and benefice, and the minister thereof duly "nominated and licensed thereto, and his suc-"cessors, shall be a body politic and corporate, "with perpetual succession, and may receive "and take to himself and his successors all such "lands, tenements, tithes, rent charges, and "hereditaments as shall be granted unto him or "them, and such perpetual curate shall thence-"forth have within the limits of the district " parish formed under the Church Building Acts, "for the church of such perpetual curacy, sole "and exclusive cure of souls, and shall not in "anywise be subject to the control or interference " of the Incumbent or Incumbents of the benefice "or benefices to be affected by such Order, if he " or they shall have consented to such Order as " aforesaid."

And whereas the Right Honourable and Most Reverend William Dalrymple, Lord Archbishop of York, hath pursuant to the enactment aforesaid, made a report to His Majesty in Council, dated the twenty-first day of February, one thousand nine hundred and two, in the words

and figures following, that is to say:—
"The undersigned William Dalrymple by Divine
Providence Lord Archbishop of York Primate of England and Metropolitan in pursuance of an Act passed in the first and second years of the reign of Her late Majesty Queen Victoria entitled 'An Act to abridge the holding of benefices in plurality and to make better provision for the residence of the clergy' doth hereby report to Your Majesty as follows:

"That there is in the county and diocese of York the district of Anlaby which includes certain portions of parishes of Kirk Ella, Hessle, Cottingham and North Ferriby.

"That the said district is more particularly delineated and described in the map or plan hereunto annexed and thereon coloured round with a red verge line the portions of the said parishes comprised therein being coloured respec-

tively yellow, blue, pink, and green.

"That according to the last census the populations of the said parishes of Kirk Ella, Hessle, Cottingham and Ferriby including the inhabitants of the portions of such parishes comprised within the said district are respectively Hessle 3,754, North Ferriby and Swanland 899, Kirk Ella 1,675, Cottingham 3,910 and that the estimated population of the said district is 1,128.

"That there is a consecrated church situated at Anlaby in that portion of the parish of Kirk Ella included within the boundaries of the said district of Anlaby which is at present a chape.

of ease to the said parish of Kirk Ella.

"That it is proposed that the church situated at Anlaby together with the said portions of the parishes of Kirk Ella, Hessle, Cottingham and

North Ferriby shall be severed from the parishes to which these now respectively belong and be constituted a separate benefice and a parish for ecclesiastical purposes under the name or style of the new vicarage of Anlaby.
"That the annual values of the benefices pro-

posed to be affected by this scheme are as follows:—Kirk Ella £625 16s. 0d. Hessle £450 Cottingham £300 and North Ferriby £292

18s. 10d.

"That the patronage of the vicarage of Kirk Ella is vested in the Reverend James Foord who

is also the vicar thereof.

"That the patronage of the vicarage of Hessle is vested in Your Majesty and the Reverend Arnold Wordsworth Savory is the present vicar thereof, that the Right Reverend Francis John Lord Bishop of Chester is the patron of the rectory of Cottingham in right of his See and the Reverend Francis Minton is the present rector thereof and that the patronage of the vicarage of North Ferriby is vested in Anne Turner of Dingle Head near Liverpool in the county of Lancaster Widow and the Reverend Stephen Septimus Farrow is the present vicar thereof all of whom are consenting parties to the present

"That if the present scheme is carried into effect the Governors of the Bounty of Queen Anne for the augmentation of the maintenance of the poor clergy have undertaken to make a grant of a capital sum of £600 towards the permanent endowment of the said proposed

separate parish.

"The vicar of Kirk Ella has agreed to transfer a modus of £12 at present part of the endowment of his benefice and the vicar of Hessle has agreed to transfer a modus of £7 10s. Ud. now part of the endowment of his benefice as and for the endowment of the said new parish in the manner

appearing in the scheme hereto annexed.
"That Joseph Robinson Pease J.P. of Hesslewood, Hessle the Lay Impropriator of the vicarage of Hessle has agreed to assign a modus of £7 10s. 0d. at present payable to him and steps will be taken to secure this as part of the permanent endowment of the proposed new

parish. "That there is a sum of £2,333 invested in the names of James Foord and Charles Coleridge Mackarness in North Eastern Railway Debentures and it is proposed that this should be transferred to the York Board of Diocesan Trustees as part of the permanent endowment of the said new parish and that a further sum of £1,000 is available for such endowment and it is proposed to pay over this last-named sum to the said Governors of the Bounty of Queen Anne for the augmentation of the maintenance of the poor clergy in further augmentation of such endowment.

"That it appears to the said Archbishop that under the provisions of the Acts of Parliament passed in the session held in the first and second years of Her said late Majesty's reign chapter one hundred and six and of the second and third years of Her said late Majesty's reign chapter forty-nine the said portions of the parishes of Kirk Ella, Hessle, Cottingham and North Ferriby comprised within the boundaries of the said district of Anlaby may be severed from the parishes to which these now respectively belong and be constituted a separate benefice and a parish for ecclesiastical purposes.

"That pursuant to the directions contained in the twenty-sixth section of the aforesaid firstmentioned Act the said Archbishop has prepared a scheme in writing appended to this report describing the mode in which it appears to him
