

that the alterations above mentioned may be best effected and the said Archbishop being on full consideration and enquiry satisfied with such scheme he doth by this report to Your Majesty in Council certify the same to Your Majesty together with the consent in writing to the said scheme of the patrons and Incumbents of the benefices affected thereby to the intent that Your Majesty in Council in case it shall be thought expedient so to do may make an Order for carrying such scheme into effect.

And whereas the scheme and consents referred to in the said Archbishop's report are in the words and figures following:—

"The SCHEME referred to in the foregoing report.

"That the portions of the parishes of Kirk Ella, Hessle, Cottingham and North Ferriby particularly delineated and described on the map or plan hereto annexed coloured respectively yellow, blue, pink and green comprised within a red verge line shall be severed from the parishes to which these now respectively belong and be united together and constituted a separate benefice and a parish for ecclesiastical purposes under the name or style of the new parish of Anlaby of which the recently consecrated church of Saint Peter situated at Anlaby shall be the parish church.

"That the proposed separate parish and benefice of Anlaby shall be subject to the same ecclesiastical jurisdiction as the benefices of Kirk Ella, Hessle, Cottingham and North Ferriby and the Incumbent of the said new parish shall have exclusive cure of souls within the limits of the same.

"That two churchwardens shall be chosen annually in the accustomed manner and at the time when churchwardens are annually appointed in or for such separate parish or benefice and every person so appointed shall be duly admitted and shall do all things pertaining to the office of churchwarden as to ecclesiastical matters within the said parish.

"That all fees and payments for christenings marriages burials and other ecclesiastical offices solemnized within the said new parish of Anlaby shall thenceforth belong to the Incumbent thereof.

"That the parishioners of the said proposed separate parish of Anlaby shall not be entitled to any accommodation in the parish churches of Kirk Ella, Hessle, Cottingham or North Ferriby as the case may be.

"That from and after the publication in the London Gazette of any Order of Your Majesty in Council carrying this scheme into effect a modus of £12 charged on the lands in the parishes of Kirk Ella and North Ferriby and payable to the vicar of Kirk Ella and a modus of £7 10s. 0d. charged on lands in the parish of Hessle and payable to the vicar of Hessle shall belong to and become part of an endowment for the minister of the said proposed new parish of Anlaby.

WHEREAS the Ecclesiastical Commissioners for England have in pursuance of the Act of the sixth and seventh years of His late Majesty King William the Fourth chapter seventy-seven of the Act of the third and fourth years of Her late Majesty Queen Victoria chapter one hundred and thirteen and of the Act of the thirty-seventh and thirty-eighth years of Her said late Majesty chapter sixty-three duly prepared and laid before His Majesty in Council a scheme bearing date the sixth day of March, in the year one thousand nine hundred and two, in the words and figures following, that is to say:—

"We the Ecclesiastical Commissioners for England acting in pursuance of the Act of the sixth and seventh years of His late Majesty King William the Fourth, chapter seventy-seven, of the Act of the third and fourth years of Her late Majesty Queen Victoria chapter one hundred and thirteen, and of the Act of the thirty-seventh and thirty-eighth years of Her said late Majesty chapter sixty-three, have prepared and now humbly lay before Your Majesty in Council the following scheme with respect to the rural deaneries or some of them which are within the archdeaconry of Warrington within the diocese of Liverpool.

"Whereas by an Order of Her said late Majesty in Council bearing date the twentieth day of June in the year one thousand eight-hundred and eighty-two and published in the London Gazette on the fourteenth day of the month following there were effected certain rearrangements of the areas of the archdeaconry of Liverpool in the said diocese of Liverpool and the said archdeaconry of Warrington and some of the rural deaneries therein.

"And whereas by another Order of Her said late Majesty in Council bearing date the eleventh day of May in the year one thousand eight hundred and ninety-five and published in the London Gazette on the seventeenth day of the same month there were effected certain further rearrangements of the areas of the said archdeaconries of Liverpool and Warrington and some of the rural deaneries therein.
