

"And we further recommend and propose that nothing herein contained shall prevent us from recommending and proposing any other measures relating to the matters aforesaid or any of them in accordance with the provisions of the said Acts or of any of them or of any other Act of Parliament.

"The SCHEDULE to which the foregoing Scheme has reference.

"The District of Saint Aldhelm Bedminster comprising :—

"All those contiguous portions of the parish of Bedminster the district parish of Saint Paul Bedminster the new parish (sometime district) of Saint Francis Ashton Gate Bedminster and of the new parish (sometime chapelry district) of Saint Peter Bishopsworth all in the suburbs of the city of Bristol and in the diocese of Bristol which are comprised within and are bounded by an imaginary line commencing at the junction of South-street with North-street where the boundaries of the said parish of Bedminster the said district parish of Saint Paul Bedminster and the said new parish of Saint Francis Ashton Gate Bedminster all meet and extending thence north-eastward along the boundary which divides the said parish of Bedminster from the said district parish of Saint Paul Bedminster (thereby following the middle of the last-named street) for a distance of five chains and a half or thereabouts to the junction of the said last-named street with King William-street and extending thence north-westward along the middle of the last-named street for a distance of four chains and a half or thereabouts to the wall or fence at its north-western end and continuing thence in the same direction and in a straight line for a distance of four chains or thereabouts (thereby crossing the premises of the North-street Brick and Tile Works) to a point in the middle of Greville-road and extending thence first south-westward then north-westward and then again south-westward along the middle of the last-named road (thereby crossing the boundary which divides the said district parish of Saint Paul Bedminster from the said new parish of Saint Francis, Ashton Gate, Bedminster) for a distance of seventeen chains or thereabouts to its junction with North-street aforesaid and extending thence south-eastward along the middle of the last-named street for a distance of two chains and a half or thereabouts to its junction with Luckwell-lane, and extending thence south-westward along the middle of the last-named lane for a distance of two chains and a half or thereabouts to a point opposite the footpath leading from the last-named lane to Ashton Vale and extending thence south-westward to and along the middle of the last-mentioned footpath for a distance of thirty-seven chains or thereabouts to the point near its junction with Marsh-lane where such footpath meets the boundary which divides the said new parish of Saint Francis Ashton Gate Bedminster from the said new parish of Saint Peter Bishopsworth and extending thence first southward and then south-eastward along the last-mentioned boundary (thereby following generally the course of the last-named lane) for a distance of nine chains or thereabouts to the junction of the last-named lane with the lane known as South Liberty-lane or Water-lane and extending thence first south-westward and then south-eastward along the middle of the last-mentioned lane for a distance of thirty-three chains and a half or thereabouts to its junction with South-lane and extending thence southward and in a straight line for a distance of thirty-one

chains or thereabouts to the milestone indicating a distance of two miles from Bristol on the high road from Bristol to Bridgwater and extending thence south-eastward and in a straight line for a distance of twenty-five chains and a half or thereabouts to the milestone indicating a distance of two miles from Bristol on the road from Bristol to Chew Stoke and extending thence north-eastward and in a straight line for a distance of fifty-eight chains or thereabouts to the point where Nover's-lane is joined by the roadway leading from the Fever Hospital for Women upon the boundary which divides the said new parish of Saint Peter Bishopsworth from the parish of Bedminster aforesaid and extending thence first northward and then north-westward along the middle of Nover's-lane aforesaid (thereby following the last-mentioned boundary) for a distance of thirty-five chains or thereabouts to a point opposite to the footpath leading to Bartlett's-lane and extending thence north-westward to and along the middle of the last-mentioned footpath for a distance of twenty-three chains and a half or thereabouts to the centre of the bridge over the main line of the Great Western Railway which connects such footpath with Bartlett's-lane aforesaid and extending thence north-eastward along the middle of the said line of railway for a distance of six chains or thereabouts to a point opposite to the south-eastern end of the wall or fence forming the south-western boundary of the property belonging to the Malago Vale Colliery and extending thence north-westward to and along the said wall or fence and along the wall or fence forming the south-western boundary of the Red Cow public-house for a distance of ten chains or thereabouts to its north-western end on the south-eastern side of West-street and continuing thence north-westward and in a straight line for a distance of twenty-five feet or thereabouts to the middle of the last-named road upon the boundary which divides the said parish of Bedminster from the said new parish of Saint Francis Ashton Gate Bedminster and extending thence first north-eastward and then north-westward along the last-mentioned boundary (thereby following the middles of West-street Clifton-street and South-street) for a distance of twenty-five chains or thereabouts to the junction of South-street with North-street as aforesaid where the boundaries of the said parish of Bedminster the said new parish of Saint Francis Ashton Gate, Bedminster and the said district parish of Saint Paul Bedminster all meet at which point the said imaginary line commenced."

And whereas drafts of the said scheme have, in accordance with the provisions of the secondly hereinbefore mentioned Act, been transmitted to the patron and to the Incumbent of the cures out of which it is intended that the district recommended in such scheme to be constituted shall be taken, and such patron and Incumbent have respectively signified their assent to such scheme :

And whereas the said scheme has been approved by His Majesty in Council: Now, therefore, His Majesty, by and with the advice of His said Council, is pleased hereby to ratify the said scheme, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts; and His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said diocese of Bristol.
